(1) registers and pays the specified fee for the unmanned aircraft system under Minnesota Statutes, section 360.55, subdivision 9, for the same registration period or an overlapping registration period; or

(2) is exempt from payment of the tax under Minnesota Statutes, sections 360.531 to 360.67, and the fee under Minnesota Statutes, section 360.55, subdivision 9, as provided under this act.

(b) An amount necessary for any refunds under paragraph (a) is appropriated in fiscal year 2018 from the state airports fund to the commissioner of transportation for the purposes of providing refunds.

Sec. 6. **EFFECTIVE DATE.**

This act is effective July 1, 2017."

The council shall consult with the commissioner of employment and economic development in developing the study, determining what data available to the commissioner would be useful, and how to collect any other data necessary or useful to the analysis. At a minimum, the council must solicit from cities, business associations, and individual businesses data that shows what percentage of initial costs a small business incurs is due to SAC imposed by the council. "Initial costs" includes those costs incurred, whether paid or not, during the one to two year period before opening. The report must also include how many businesses asked for reduced SAC or deferment of payments and at what point in the process of developing or expanding the business, how many received reductions, and in what amounts. The report must identify specific changes to SAC that will reduce the

burden on small businesses and encourage their development and expansion, and how each option will affect other rate payers. The report may include specific case studies of small business experience with SAC. "Small business" has the meaning given in Minnesota Statutes, section 645.445.

EFFECTIVE DATE. This section is effective the day following final enactment and applies in the counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington."
