1.5 Subd. 6. **Campus sexual assault data.** Data relating to allegations of sexual assault  
1.6 at a postsecondary institution are classified in section 135A.15.

1.7 Sec. 2. Minnesota Statutes 2014, section 135A.15, subdivision 1, is amended to read:

1.8 Subdivision 1. **Policy required.** The Board of Trustees of the Minnesota State  
1.9 Colleges and Universities shall, and the University of Minnesota is requested to, adopt  
1.10 a clear, understandable written policy on sexual harassment and sexual violence that  
1.11 informs victims of their rights under the crime victims bill of rights, including the right to  
1.12 assistance from the Crime Victims Reparations Board and the commissioner of public  
1.13 safety. The policy must apply to students and employees and must provide information  
1.14 about their rights and duties. The policy must apply to criminal incidents against a student  
1.15 or employee of a postsecondary institution occurring on property owned or leased by the  
1.16 postsecondary system or institution ~~in which the victim is a student or employee of that~~  
1.17 ~~system or institution~~ or at any activity, program, organization, or event sponsored by the  
1.18 system or institution, including fraternities and sororities. It must include procedures for  
1.19 reporting incidents of sexual harassment or sexual violence and for disciplinary actions  
1.20 against violators. During student registration, each technical college, community college,  
1.21 or state university shall, and the University of Minnesota is requested to, provide each  
1.22 student with information regarding its policy. A copy of the policy also shall be posted  
1.23 at appropriate locations on campus at all times. Each private postsecondary institution  
1.24 that is ~~an eligible institution as defined in section 136A.155~~ registered as a postsecondary  
1.25 institution under section 136A.65, must ~~adopt a policy that meets the~~ comply with the

2.2 Subd. 2. **Victims' rights.** (a) The policy required under subdivision 1 shall, at  
2.3 a minimum, require that students and employees be informed of the policy, and shall  
2.4 include provisions for:

2.5 (1) filing criminal charges with local law enforcement officials in sexual assault cases;

2.6 (2) the prompt assistance of campus authorities, at the request of the victim, in  
2.7 notifying the appropriate law enforcement officials and disciplinary authorities of a  
2.8 sexual assault incident;

2.9 (3) allowing sexual assault victims to decide whether to refer a case to law  
2.10 enforcement;

2.11 (4) requiring campus authorities to treat sexual assault victims with dignity;

2.12 (5) requiring campus authorities to offer sexual assault victims fair and respectful  
2.13 health care, counseling services, or referrals to such services;

2.14 (6) preventing campus authorities from suggesting a victim of sexual assault is at  
2.15 fault for the crimes or violations that occurred;

3.25 Sec. 4. Minnesota Statutes 2014, section 135A.15, is amended by adding a subdivision  
3.26 to read:

3.27 Subd. 3. **Uniform amnesty.** The Board of Trustees of the Minnesota State Colleges  
3.28 and Universities shall, and the University of Minnesota is requested to, include in the  
3.29 system's sexual harassment and violence policy, a provision that no student who reports,  
3.30 in good faith, an act of sexual harassment or sexual violence shall be sanctioned by the  
3.31 institution for admitting to a violation of the institution's student conduct policy on the  
3.32 use of drugs or alcohol as part of the report. Each private postsecondary institution that is  
3.33 registered under section 136A.65 must comply with the requirements of this subdivision.

4.2 to read:

4.3 Subd. 4. **Coordination with local law enforcement.** (a) The Board of Trustees  
4.4 of the Minnesota State Colleges and Universities shall, and the University of Minnesota  
4.5 is requested to, direct each campus in the system to enter into a memorandum of  
4.6 understanding with the primary local law enforcement agencies that serve the campus.  
4.7 The memorandum must be entered no later than January 1, 2017, and updated every two  
4.8 years thereafter. Each private postsecondary institution that is registered under section  
4.9 136A.65 must comply with the requirements of this subdivision. This memorandum shall  
4.10 clearly delineate responsibilities and require information sharing, in accordance with  
4.11 applicable state and federal privacy laws, about certain crimes including, but not limited  
4.12 to, sexual assault. This memorandum of understanding shall provide:

4.13 (1) delineation and sharing protocols of investigative responsibilities;

4.14 (2) protocols for investigations, including standards for notification and

4.29 Subd. 5. **Online reporting system.** (a) The Board of Trustees of the Minnesota  
4.30 State Colleges and Universities shall, and the University of Minnesota is requested to,  
4.31 provide an online reporting system to receive complaints of sexual harassment and sexual  
4.32 violence from students and employees. The system must permit anonymous reports,  
4.33 provided that the institution is not obligated to investigate an anonymous report, unless  
4.34 a formal report is submitted through the process established in the institution's sexual  
4.35 harassment and sexual violence policy or an investigation is otherwise required by law.

5.11 to read:

5.12 Subd. 6. **Data collection and reporting.** (a) The Board of Trustees of the  
5.13 Minnesota State Colleges and Universities and the University of Minnesota shall annually  
5.14 report statistics on sexual assault. Each private postsecondary institution that is registered  
5.15 under section 136A.65 must comply with the requirements of this subdivision. This report  
5.16 must be prepared in addition to any federally required reporting on campus security,  
5.17 including reports required by the Jeanne Clery Disclosure of Campus Security Policy and  
5.18 Campus Crime Statistics Act, United States Code, title 20, section 1092(f). The report  
5.19 must include, but not be limited to:

5.20 (1) the number of incidents that were investigated by the institution;

5.21 (2) the number of incidents that were referred for a disciplinary proceeding at the  
5.22 institution;

5.23 (3) the number of incidents that the victim chose to report to local or state law  
5.24 enforcement;

5.25 (4) the number of alleged perpetrators that were found responsible by the disciplinary  
5.26 proceeding at the institution;

5.27 (5) the number of disciplinary proceedings at the institution that resulted in any  
5.28 action by the institution greater than a warning issued to the accused;

5.29 (6) the number of disciplinary proceedings at the institution that have closed without  
5.30 resolution;

5.31 (7) the number of disciplinary proceedings at the institution that were closed without  
5.32 resolution because the accused withdrew from the institution;

5.33 (8) the number of disciplinary proceedings at the institution that have closed without  
5.34 resolution because the victim chose not to participate in the procedure; and

6.1 (9) the number of reports made through the online reporting system established in  
6.2 subdivision 5, excluding reports submitted anonymously.

6.3 (b) The data reported as part of this subdivision shall be provided as summary data  
6.4 as defined by section 13.02, subdivision 19, and shall not identify alleged victims or  
6.5 perpetrators of crimes. The report required by this section must be submitted to the Office  
6.6 of Higher Education. The Office of Higher Education shall publish the data reported under  
6.7 this subdivision on its Web site. Each technical college, community college, or state  
6.8 university shall, and the University of Minnesota is requested to, publish the data reported  
6.9 as part of this subdivision on its Web site. This subdivision does not require disclosure of  
6.10 data that would violate state or federal laws governing access to student records.

6.12 to read:

6.13 Subd. 7. **Access to data; audit trail.** (a) Data on incidents of sexual assault shared  
6.14 with campus security officers or campus administrators responsible for investigating or  
6.15 adjudicating complaints of sexual assault is classified as private data on individuals as  
6.16 defined by section 13.02, subdivision 12.

6.17 (b) Only individuals with explicit authorization from an institution may enter,  
6.18 update, or access electronic data collected, created, or maintained under this section. The  
6.19 ability of authorized individuals to enter, update, or access data must be limited through  
6.20 the use of role-based access that corresponds to the official duties or training level of  
6.21 the individual and the institutional authorization that grants access for that purpose. All  
6.22 queries and responses, and all actions in which data are entered, updated, accessed, or  
6.23 shared or disseminated outside of the institution, must be recorded in a data audit trail. An  
6.24 institution shall immediately and permanently revoke the authorization of any individual  
6.25 determined to have willfully entered, updated, accessed, shared, or disseminated data in  
6.26 violation of this subdivision or any provision of chapter 13. If an individual is determined  
6.27 to have willfully gained access to data without explicit authorization, the matter shall be  
6.28 forwarded to a county attorney for prosecution.

6.31 Subd. 8. **Comprehensive training.** (a) The Board of Trustees of the Minnesota  
6.32 State Colleges and Universities shall, and the University of Minnesota is requested  
6.33 to, provide campus security officers and campus administrators responsible for  
6.34 investigating or adjudicating complaints of sexual assault with comprehensive training on

7.1 preventing and responding to sexual assault in collaboration with the Bureau of Criminal  
7.2 Apprehension or another law enforcement agency with expertise in criminal sexual  
7.3 conduct. The training for campus security officers shall include a presentation on the  
7.4 dynamics of sexual assault, neurobiological responses to trauma, and best practices for  
7.5 preventing, responding to, and investigating sexual assault. The training for campus  
7.6 administrators responsible for investigating or adjudicating complaints on sexual assault  
7.7 shall include presentations on preventing sexual assault, responding to incidents of  
7.8 sexual assault, the dynamics of sexual assault, neurobiological responses to trauma, and  
7.9 compliance with state and federal laws on sexual assault.

7.10 (b) The Board of Trustees of the Minnesota State Colleges and Universities shall,  
7.11 and the University of Minnesota is requested to, require that each incoming student  
7.12 complete training on sexual assault no later than ten business days after the start of a  
7.13 student's first semester of classes. Once a student completes such training, institutions  
7.14 must document the completion of such a course on the student's transcript. Students who  
7.15 previously completed a campus training on sexual assault that is documented on their  
7.16 transcript are exempt from this requirement. This training shall include information about  
7.17 topics including, but not limited to, sexual assault as defined in subdivision 2 of this  
7.18 section; consent as defined in section 609.341, subdivision 4; preventing and reducing the  
7.19 prevalence of sexual assault; procedures for reporting campus sexual assault; and campus  
7.20 resources on sexual assault, including organizations that support victims of sexual assault.

7.21 (c) The Board of Trustees of the Minnesota State Colleges and Universities shall,  
7.22 and the University of Minnesota is requested to, annually train individuals responsible  
7.23 for responding to reports of sexual assault. This training shall include information about  
7.24 best practices for interacting with victims of sexual assault, including how to reduce the  
7.25 emotional distress resulting from the reporting, investigatory, and disciplinary process.

7.26 (d) Each private postsecondary institution that is registered under section 136A.65  
7.27 must comply with the requirements of this subdivision.

7.29 subdivision to read:

7.30 Subd. 9. **Student health services.** (a) The Board of Trustees of the Minnesota  
7.31 State Colleges and Universities shall, and the University of Minnesota is requested to,  
7.32 develop and implement a policy that requires student health service providers to screen  
7.33 students for incidents of sexual assault. Student health service providers shall offer  
7.34 students information on resources available to victims and survivors of sexual assault

8.1 including counseling, mental health services, and procedures for reporting incidents of  
8.2 sexual assault to the institution.

8.3 (b) The Board of Trustees of the Minnesota State Colleges and Universities shall, and  
8.4 the University of Minnesota is requested to, require that each institution offering student  
8.5 health or counseling services designate an existing staff member or existing staff members  
8.6 as confidential resources for victims of sexual assault. The confidential resource must be  
8.7 available to meet with victims of sexual assault on a walk-in basis. The confidential  
8.8 resource must provide victims of sexual assault with information about locally available  
8.9 resources for victims of sexual assault, including, but not limited to, mental health services  
8.10 and legal assistance. The confidential resource must provide victims of sexual assault  
8.11 with information about the process for reporting an incident of sexual assault to campus  
8.12 authorities or local law enforcement. The victim of sexual assault shall decide whether  
8.13 to report an incident of sexual assault to campus authorities or local law enforcement.  
8.14 Confidential resources must be trained in all aspects of responding to incidents of sexual  
8.15 assault including, but not limited to, best practices for interacting with victims of trauma,  
8.16 preserving evidence, campus disciplinary and local legal processes, and locally available  
8.17 resources for victims of sexual assault. Data shared with a confidential resource is  
8.18 classified as sexual assault communication data as defined by section 13.822, subdivision 1.
