The Northwest Minnesota business delegation will be meeting with me and several of my legislative colleagues in room 300S at the State Office Building (across the street from the State Capitol Building) from 1:15 to 2:30 p.m. Your business concerns will be heard and your questions will be answered.

#### 2:30 p.m. Press Conference with Dan Fabian

Join me for a press conference in room 181 of the State Office Building where members of the media will hear directly from me as well as from Northwest Minnesota business leaders regarding their concerns and what they will need to continue to create jobs in Northwest Minnesota.

## 3:00 p.m. State Capitol Tour (Optional)

Cross the street to the State Capitol and take a guided tour before your bus returns to the Crowne Plaza.

## 3:45 p.m. Buses Return to the Crowne Plaza

Buses will pick up where they dropped off earlier in the afternoon. A 10-minute trip will bring you back to the Crowne Plaza Hotel.

## 4:00 – 5:30 p.m. Networking Reception

We want to know how your day of lobbying went, so stay for a refreshment and some camaraderie while sharing your success story of the day. Refreshments and light appetizers will be served. The Northwest Minnesota delegation will have an opportunity to connect once again at this time.

Governor Dayton's current budget proposal calls for \$37.9 billion in state spending over the next two years, a 7.6% increase in spending that is paid for by an astonishing 11.9% in taxes. Governor Dayton's promise of a balanced approach to the budget is out of balance, because his budget includes \$3.7 billion dollars in tax increases and only \$225 million in cuts, which is a 16:1 ratio of tax increases to spending cuts. This budget will negatively impact job creators. Governor Dayton's sales tax expansion will be unprecedented, introducing many unfavorable business to business taxes that will make the cost of doing business higher than ever before. The personal income tax increase proposed by the governor will impact most of the 92% of business owners in Minnesota who file through individual tax returns and would be hurt by this vast tax hike.
