## 2007 State Fair Poll Results

Gas tax increase favorable to majority of voters

More than 58 percent of those participating in the 2007 House of Representatives State Fair Poll support raising the state's gas tax by a dime if all the money goes toward state road and bridge improvements.

During the 12-day run of the Minnesota State Fair, 6,678 fairgoers took the poll conducted by nonpartisan House Public Information Services. It is an informal, unscientific survey on issues discussed in prior legislative sessions, and may again be topics of discussion.

Since the Interstate 35W bridge collapse Aug. 1, there has been more talk about increased transportation funding, including a possible gas tax increase. A 7.5cent increase was in the omnibus transportation finance bill vetoed by the governor earlier this year. The gas tax has been at 20 cents per gallon since 1988.

Last year, just 41 percent of polltakers supported a 10cent per gallon increase in the state gasoline tax to fund transportation improvements; however, 53.6 percent of 2005 polltakers said yes to: "In general, do you support increasing the gas tax to fund road and bridge projects?"
While a gas tax increase may be palatable to the majority of polltakers, 48.7 percent do not support raising the state sales tax by three-eighths of 1 percent and dedicating the money to environment and arts funding. Nearly 42 percent said yes to the question that was based on bills passed by House and Senate in 2007. However, a conference committee convened on the session's final day to try to work out a compromise on allocating the money ran out of time.
Favorable responses were given to a pair of educationrelated questions. More than two-thirds of voters believe state funding should be increased to provide for fullday kindergarten, if a district chooses to offer this. More than 61 percent believe grants should be made to public school districts to provide locally grown food as part of their lunch programs.

Also in the food area, 68.6 percent of polltakers think people should not be allowed to sue food manufacturers and vendors for weight gain as a result of consuming certain foods.
Nearly 71 percent of voters believe the state should be required to ensure affordable, comprehensive health care for all Minnesotans, and 58 percent support the use of marijuana for medical purposes.

On the heels of a smoking ban passed into law, more than 70 percent of voters think smoking should be banned within 50 feet of an entrance to public buildings.
Stadia being built for the Minnesota Twins and University of Minnesota are being partially financed with public dollars. However, just 13 percent of those taking the poll believe public financing should be used to help construct a stadium to house the Minnesota Vikings. The team has proposed a nearly $\$ 1$ billion facility on the Metrodome site.
Two-thirds of voters believe the fine for moving traffic violations should be doubled if the driver was using a cell phone at the time of the infraction; 57.6 percent support car dealers and liquor stores being open on Sundays; 45.8 percent believe veterans should be given Veterans Day off with pay; and 45.3 percent support $\$ 260$ million in bonding to restore and expand the State Capitol. However, nearly one-quarter of voters had no opinion on the issue, or were undecided.

And, finally, 47.3 percent of polltakers said the Tilt-A-Whirl, invented in Faribault, should be designated the state amusement ride. However, 31.2 percent had no opinion.
