### Overview

In 1986 the legislature enacted the Farmer-Lender Mediation Program to protect farmers from foreclosures triggered by declining land values and low crop prices. The law was scheduled to be repealed on July 1, 1988. Successive legislatures have amended and extended the repeal date on 12 occasions over the past 18 years. In each instance the extension was accomplished by amending the uncodified "repealer" section of the original 1986 law. House File 426 creates a new statutory section to extend the expiration date to June 30, 2009.

#### Section

**Expiration.** A new section of statute is created as a mechanism to establish the date the Farmer-Lender Mediation Program will expire. The date designated is June 30, 2009.

**Repealer.** The repeatedly-amended section of the 1986 law is repealed. <sup>1</sup>
