Overview

Advances the various dates for the truth-in-taxation process. Effective for notices, advertisements, and hearings held in 2005 and thereafter.

Section

- **Proposed levy.** Advances the dates for certifying the proposed levies (proposed budget in the case of school districts) to the county auditor. See table.
- **Overlapping jurisdictions.** Advances the date for the home county auditor to certify proposed levies in the case of districts located in more than one county. See table.
- 3 Levy; shared; merged; consolidated services. Advances the date for amending the proposed levy on any agreement for two or more districts that are sharing, merging, or consolidating services. See table.
- **4 Truth-in-Taxation (TnT) notice.** Advances the date (see table):
 - that the auditor/treasurer sends out the TnT notices;
 - that the market values used for the TnT calculations and notices are "finalized"; and
 - when the TnT notice must be given to apartment tenants or posted in the apartment building.
- 5 Public hearings; Adoption of budget and levy. Advances all the dates for the public

hearings; including the initial hearing, any necessary additional initial hearings, and any continuation hearings. See table.
