Overview

This bill repeals outdated statutes relating to county and municipal courts as a result of trial court unification; moves relevant county and municipal court statutes to chapter 484; amends statutes to reflect the creation of the Judicial Council (new governance body for the judicial branch) and the sunset of the Conference of Chief Judges (former governance body for the trial courts); and removes outdated language from other court statutes.
