## Overview

This bill increases the exemption under the estate from \$1 million to \$2 million, effective for estates of decedents dying after December 31, 2012. In addition, the bill reduces the combined exemptions for qualified small business and farm property from \$4 million to \$3 million.

## **Section**

**Filing requirement.** Increases the threshold that requires filing an estate tax return from a federal gross estate of \$1 million to \$2 million.

**Effective date:** Decedents dying after December 31, 2012.

**Estate tax exemptions.** Modifies computation of the estate tax to increase the general exemption available to all estates from \$1 million to \$2 million and reduces the combined exemptions for qualified small business and farm property from \$4 million to \$3 million.

**Effective date:** Decedents dying after December 31, 2012.
