## City aids and credit cuts in Pay 2010 under HF 1136 (the Governor's proposal)

The attached run shows the certified Pay 2009 under current law and the cuts proposed for Pay 2010 under HF 1136, the governor's proposal. The reductions shown **do not include the elimination of the 2% growth in the LGA appropriation that would have occurred between 2009 and 2010 under current law.** The 2% growth would have increased LGA in pay 2010 by another \$10.5 million.

The Pay 2010 cuts are equal to 10.55 percent of the city's Pay 2009 levy plus aid base. The cut is made first from LGA payments at the Pay 2009 certified amounts, and then if necessary from homestead market value (MV) credit reimbursements.

- **Column 2:** Estimated 2009 homestead market value (MV) credit payments
- **Column 3:** Total of LGA and MV credits in Pay 2009 before any reductions
