

Comparison of projected baseline 2009 LGA with LGA under H.F.3756 if there is no appropriation increase under the bill

The attached run shows certified 2008 LGA; projected (baseline) 2009 LGA under current law, including the changes enacted in Minn. Laws 2008, Chap.154; and 2009 LGA under H.F. 3756 *assuming no increase in the LGA appropriation and no "scale back" mechanism.*

Baseline LGA: The baseline assumes a projected 2007 population, based on historical data, and updated data for percent of property classified as commercial/industrial; 2008 levies and updated adjusted net tax capacities that incorporate class rate changes in Chapter 154. The adjustments to city aid base in chapter 154 are also reflected. These changes are also incorporated into the proposal run, to the extent that data is used.

H.F. 3756 proposal: The bill makes the following changes to current law for Pay 2009:

- adds a minimum level for large city need equal to \$290 per capita;
- eliminates the regional center aid and the small city aid portions of current city aid base and replaces them with two new pots – a small city aid base of \$12 per capita for cities under 5,000 population; and a new city jobs based aid for cities with a population over 5,000;
- calculation of the Pay 2009 formula aid is based on the factors used to calculate Pay 2008 LGA;
- the maximum LGA increase in Pay 2009 for any city is increased to 75 percent of the previous year's levy;
- the total LGA appropriation is increased by \$90 million.

City jobs base aid is equal to \$55 per capita (\$75 per capita for Moorhead) multiplied by population and by the ratio of employees to population in the city. The amount is increased by an extra \$100,000 for nonmetro cities with a population between 15,000 and 30,000; and by an extra \$350,000 for nonmetro cities with a population greater than 30,000.

Changes in this modified proposal from the bill:

- The appropriation remains at \$485 million.
- Eliminates the bill provision that states if the appropriation is less than \$575 million, each city's *increase* over their Pay 2008 LGA amount is scaled back proportionately.
- Reinstates the current law maximum aid increase in one year equal to 10 percent of the city's previous year's levy.
