The Minnesota Workforce Development Fund

July 2018

This paper provides a summary of Minnesota's workforce development fund (WDF) managed by the Job Skills Partnership Board.

Background

The WDF was created in the laws of 1990 as a dedicated fund for the dislocated worker program managed by the Job Skills Partnership Board (M.S. 116L.17). The Board, in consultation with local units of government, is to provide employment transition services, support services, short term training to enhance current skills in a similar occupation or industry, and long term training in a new occupation or industry for dislocated workers as a result of individual or small layoffs. Additionally, the Board will provide direct training services requested by a qualifying employer, rapid response activities during plant closings or mass layoffs, and administer CLIMB (Converting Layoffs Into Minnesota Businesses), a program that provides entrepreneurial training and technical assistance to assist dislocated workers in starting new businesses.

Resources

For 2018, every employer pays a .10 percent special assessment on all taxable wages up to \$32,000 for each employee (M.S. 268.035 subd. 24). The special assessment is subject to all the same requirements as the Minnesota unemployment insurance program and is deposited into the WDF (M.S. 116L.20). In fiscal year 2017, the Board collected \$56.425 million through the special assessment; an increase of 7.5% over FY2016.

In addition to the revenue deposited into the fund each year, the unspent balance from the prior year does not cancel to the general fund and is also available for use. The prior year balance available in fiscal year 2018 is \$22.124 million with

an average of \$25.911 million that has gone unspent each year between fiscal years 2014 and 2018. In forecast years (fiscal year 2018 and beyond), the Board forecasts that it will use all funds available for the dislocated worker program, less \$1 million. Because of this planning method, determining the actual budgetary balance cannot be done until spending numbers are reported at the close of the fiscal year.

Uses

Except for money appropriated or transferred by the legislature for other purposes (which often occurs, see figure 2), all money in the fund goes to the Job Skills Partnership Board for the State Dislocated Workers Program. However, if after March 1 of each fiscal year, the board determines money remains in the fund after the requirements under the state dislocated workers program have been satisfied, it can use remaining funds for grants under the job skills partnership program (M.S. 116L.02), the partnership program (M.S. 116L.04), the pathways program (M.S. 116L.04), or for incumbent worker training services (116L.18).

The legislature directly appropriated more spending from the fund during the 2016-17 and 2018-19 biennia compared to the 2014-15 biennium. However, if the 2019 legislature does not make any spending changes from the fund, then directly appropriated spending is projected to return to rates akin to the 2014-15 biennium in fiscal years 2020 and 2021 (see figure 2).

FIGURE 2: LEGISLATIVE APPROPRIATIONS AS A PORTION OF REVENUE (\$ in thousands)

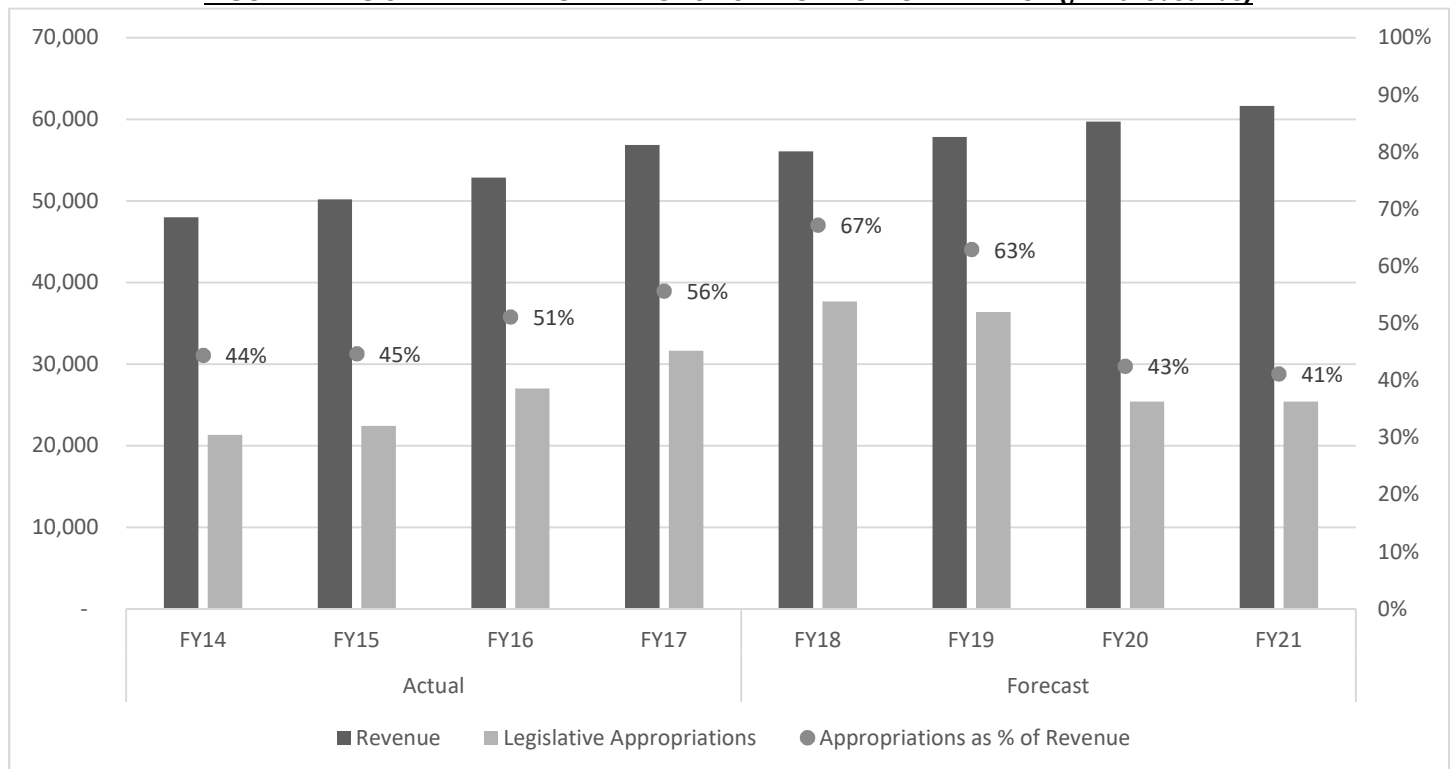
