H. F. No. 462, relating to public safety; modifying and authorizing various provisions relating to transportation, motor vehicles, and drivers; establishing requirements for meteorological towers; requiring reports.

H. F. No. 4490, relating to agriculture; providing supplemental agriculture-related appropriations for various agriculture-related purposes including appropriations for COVID-19 response efforts, farm and rural mental health services, farmers assistance, farm advocate services, farm safety, veterinary diagnostic equipment, farm loan origination fee assistance, meat and poultry processing, and retail food handler safety; providing farm safety grant and outreach programs; modifying an appropriation; making technical changes.
