EFFECTIVE DATE. This section is effective the day following final enactment.

Sec. 6. Laws 2020, Fifth Special Session chapter 3, article 2, section 2, subdivision 4, is amended to read:

Subd. 4. **Flood Mitigation** 23,000,000

From the bond proceeds account in the trunk highway fund for environmental analysis, predesign, design, engineering, and reconstruction of trunk highways that experience frequent flooding

in Sibley County and Le Sueur County, to modify the elevation of the roadways and reduce closures due to river flooding, for portions of the projects that are eligible for trunk highway bond proceeds.

EFFECTIVE DATE. This section is effective the day following final enactment."

Amend the title accordingly
