The supervising mortician supervisor is accountable for the actions of the clinical student, practicum student, or intern throughout the course of the training. The supervising mortician is accountable for any violations of law or rule, in the performance of their duties, by the clinical student, practicum student, or transfer care specialist."

Page 7, line 11, delete "six" and insert "four"

Page 7, line 13, after "program" insert "and continuing education"

Page 7, line 14, delete "that has been approved by the commissioner. To be approved," and insert "prior to initial registration."

Page 7, line 22, delete everything after "<u>complete</u>" and insert "<u>three hours of continuing education annually on</u> <u>content described in paragraph (a), clauses (1) to (3), and submit evidence of completion with the individual's</u> registration renewal."

Page 7, line 28, delete "Every five years,"

Page 7, line 29, delete everything after "<u>completion</u>" and insert "<u>of the continuing education requirements in</u> <u>subdivision 4.</u>"
