1.2 Delete everything after the enacting clause and insert:

1.3 "Section 1. Minnesota Statutes 2020, section 171.07, subdivision 1, is amended to read:

1.4 Subdivision 1. **License; contents and design.** (a) Upon the payment of the required fee,
1.5 the department shall issue to every qualifying applicant a license designating the type or
1.6 class of vehicles the applicant is authorized to drive as applied for. This license must bear:
1.7 (1) a distinguishing number assigned to the licensee; (2) the licensee's full name and date
1.8 of birth; (3) either (i) the licensee's residence address, or (ii) the designated address under
1.9 section 5B.05; (4) a description of the licensee in a manner as the commissioner deems
1.10 necessary; (5) the usual signature of the licensee; and (6) designations and markings as
1.11 provided in this section. No license is valid unless it bears the usual signature of the licensee.
1.12 Every license must bear a colored photograph or an electronically produced image of the
1.13 licensee.

1.14 (b) If the United States Postal Service will not deliver mail to the applicant's residence
1.15 address as listed on the license, then the applicant shall provide verification from the United
1.16 States Postal Service that mail will not be delivered to the applicant's residence address and
1.17 that mail will be delivered to a specified alternate mailing address. When an applicant
1.18 provides an alternate mailing address under this subdivision, the commissioner shall use
1.19 the alternate mailing address in lieu of the applicant's residence address for all notices and
1.20 mailings to the applicant.

1.21 (c) Every license issued to an applicant under the age of 21 must be of a distinguishing
1.22 color and plainly marked "Under-21."

1.23 (d) A license issued to an applicant age 65 or over must be plainly marked "senior" if
1.24 requested by the applicant.

2.1 (e) Except for a noncompliant license, a license must bear a distinguishing indicator for
2.2 compliance with requirements of the REAL ID Act.

2.3 (f) A noncompliant license must:

2.4 (1) be marked "not for federal identification" on the face and in the machine-readable
2.5 portion; and

2.6 (2) have a unique design or color indicator for purposes of the REAL ID Act.

2.7 (g) A license must be marked "not valid for voter registration or voting identification"
2.8 on the front side in a manner commensurate with other text, if it is issued under any of the
2.9 following circumstances:

2.10 (1) the application is for first-time issuance of a license in Minnesota, and the applicant
2.11 has not demonstrated United States citizenship;

2.12 (2) the applicant's most recently issued license or Minnesota identification card is marked
2.13 as required under this paragraph or subdivision 3, paragraph (g), and the applicant has not
2.14 demonstrated United States citizenship; or

2.15 (3) the applicant submits a document that identifies a temporary lawful status or admission
2.16 period.

2.17 (h) A license issued to a person with temporary lawful status or admission period must
2.18 be marked "temporary" on the face and in the machine-readable portion.

2.19 ~~(h)~~ (i) A license must display the licensee's full name or no fewer than 39 characters of
2.20 the name. Any necessary truncation must begin with the last character of the middle name
2.21 and proceed through the second letter of the middle name, followed by the last character of
2.22 the first name and proceeding through the second letter of the first name.

2.24 Subd. 3. **Identification card; content and design; fee.** (a) Upon payment of the required
2.25 fee, the department shall issue to every qualifying applicant a Minnesota identification card.
2.26 The department may not issue a Minnesota identification card to an individual who has a
2.27 driver's license, other than a limited license. The department may not issue an enhanced
2.28 identification card to an individual who is under 16 years of age, not a resident of this state,
2.29 or not a citizen of the United States of America. The card must bear: (1) a distinguishing
2.30 number assigned to the applicant; (2) a colored photograph or an electronically produced
2.31 image of the applicant; (3) the applicant's full name and date of birth; (4) either (i) the
2.32 licensee's residence address, or (ii) the designated address under section 5B.05; (5) a

3.1 description of the applicant in the manner as the commissioner deems necessary; (6) the
3.2 usual signature of the applicant; and (7) designations and markings provided under this
3.3 section.

3.4 (b) If the United States Postal Service will not deliver mail to the applicant's residence
3.5 address as listed on the Minnesota identification card, then the applicant shall provide
3.6 verification from the United States Postal Service that mail will not be delivered to the
3.7 applicant's residence address and that mail will be delivered to a specified alternate mailing
3.8 address. When an applicant provides an alternate mailing address under this subdivision,
3.9 the commissioner shall use the alternate mailing address in lieu of the applicant's residence

4.2 admission period must be marked "temporary" on the face and in the machine-readable
4.3 portion.

4.5 fewer than 39 characters of the name. Any necessary truncation must begin with the last
4.6 character of the middle name and proceed through the second letter of the middle name,
4.7 followed by the last character of the first name and proceeding through the second letter of
4.8 the first name.

4.9 ~~(i)~~ (j) The fee for a Minnesota identification card is 50 cents when issued to a person
4.10 who is developmentally disabled, as defined in section 252A.02, subdivision 2; a physically
4.11 disabled person, as defined in section 169.345, subdivision 2; or, a person with mental
4.12 illness, as described in section 245.462, subdivision 20, paragraph (c).

4.14 Subd. 4. **Identification card expiration.** (a) Except as otherwise provided in this
4.15 subdivision, the expiration date of a Minnesota identification card is the birthday of the
4.16 applicant in the fourth year following the date of issuance of the card.

4.17 (b) For an applicant age 65 or older:

4.18 (1) the expiration date of a Minnesota identification card is the birthday of the applicant
4.19 in the eighth year following the date of issuance of the card; or

4.20 (2) a noncompliant identification card is valid for the lifetime of the applicant.

4.21 (c) For the purposes of paragraph (b), "Minnesota identification card" does not include
4.22 an enhanced identification card issued to an applicant age 65 or older.

4.23 (d) The expiration date for an Under-21 identification card is the cardholder's 21st
4.24 birthday. The commissioner shall issue an identification card to a holder of an Under-21
4.25 identification card who applies for the card, pays the required fee, and presents proof of
4.26 identity and age, unless the commissioner determines that the applicant is not qualified for
4.27 the identification card.

4.29 issued to a person with temporary lawful status or admission period is (1) the last day of

5.6 **171.27 EXPIRATION OF LICENSE; MILITARY EXCEPTION.**

5.7 (a) Except as otherwise provided in this section, the expiration date for each driver's
5.8 license is the birthday of the driver in the fourth year following the date of issuance of the
5.9 license. The birthday of the driver shall be as indicated on the application for a driver's
5.10 license. A license may be renewed on or before expiration or within one year after expiration
5.11 upon application, payment of the required fee, and passing the examination required of all
5.12 drivers for renewal. Driving privileges shall be extended or renewed on or preceding the
5.13 expiration date of an existing driver's license unless the commissioner believes that the
5.14 licensee is no longer qualified as a driver.

5.15 (b) The expiration date for each under-21 license shall be the 21st birthday of the licensee.
5.16 Upon the licensee attaining the age of 21 and upon the application, payment of the required
5.17 fee, and passing the examination required of all drivers for renewal, a driver's license shall
5.18 be issued unless the commissioner determines that the licensee is no longer qualified as a
5.19 driver.

5.20 (c) The expiration date for each provisional license is two years after the date of
5.21 application for the provisional license.

5.22 (d) Notwithstanding paragraphs (a) to (c), the expiration date for a license issued to a
5.23 person with temporary lawful status or admission period is (1) the last day of the person's
5.24 legal stay in the United States, or (2) one year after issuance if the last day of the person's
5.25 legal stay is not identified.

5.26 (e) Notwithstanding paragraphs (a) to (c), the expiration date for a license that must be
5.27 marked as provided in section 171.07, subdivision 1, paragraph (g), is the earlier of (1) the
5.28 birthday of the applicant in the second year following the date of issuance of the license,
5.29 or (2) as provided in paragraph (b).

5.30 (f) Any valid Minnesota driver's license issued to a person then or subsequently serving
5.31 outside Minnesota in active military service, as defined in section 190.05, subdivision 5, in
5.32 any branch or unit of the armed forces of the United States, or the person's spouse, shall
5.33 continue in full force and effect without requirement for renewal until the date one year

6.1 following the service member's separation or discharge from active military service, and
6.2 until the license holder's birthday in the fourth full year following the person's most recent
6.3 license renewal or, in the case of a provisional license, until the person's birthday in the
6.4 third full year following the renewal.
