1.8 issued valid license from another state, or ~~is enrolled in either:~~

1.9 (i) the applicant is enrolled in behind-the-wheel training in a public, private, or
1.10 commercial driver education program that utilizes simulation or behind-the-wheel
1.11 instruction and that is approved by the commissioner of public safety; and

1.12 (ii) the applicant:

1.13 (A) has completed the classroom phase of instruction in a public, private, or
1.14 commercial driver education program that is approved by the commissioner of public
1.15 safety and that includes classroom and behind-the-wheel training; or;

1.16 (ii) ~~an approved behind-the-wheel driver education program~~ (B) has completed
1.17 home school driver training, when the student is receiving full-time instruction in a home
1.18 school within the meaning of sections 120A.22 and 120A.24, the student is working
1.19 toward a home_school diploma, the student's status as a home_school student has been
1.20 certified by the superintendent of the school district in which the student resides, and the
1.21 ~~student is taking home-classroom driver training with~~ classroom materials are approved
