

Agricultural Educator Grant Program

2016 and 2017 Grant (Minnesota Laws 2016, Ch. 189, Art. 25, S 55; Minnesota Laws 2017, 1SP Ch. 5, Art. 2, S 51)

- \$250,000 for FY17 and years thereafter.
- Grants to support districts to pay agricultural educators for summer work with high school students.
- Funding must be 1:1 district-matched for the teacher’s employment.
 - State share limited to one half of 40 working days.
- Recipient districts must annually report to Commissioner on the number of teachers funded and outcomes compared to goals set in the application.
