1.13 director, who alone or, when unable, through the individual's family has voluntarily

1.17 (2) is 21 years of age or younger and has been diagnosed with a life-threatening

1.22 team under the direction of an identifiable hospice administration to ~~terminally ill~~ hospice
1.23 patients and their families to meet the physical, nutritional, emotional, social, spiritual,
1.24 and special needs experienced during the final stages of illness, dying, and bereavement,
1.25 or during a life-threatening illness contributing to a shortened life expectancy. These

2.1 services are provided through a centrally coordinated program that ensures continuity and
2.2 consistency of home and inpatient care that is provided directly or through an agreement.

2.5 Subd. 13. **Residential hospice facility.** (a) "Residential hospice facility" means a
2.6 facility that resembles a single-family home modified to address life safety, accessibility,
2.7 and care needs, located in a residential area that directly provides 24-hour residential
2.8 and support services in a home-like setting for hospice patients as an integral part of the
2.9 continuum of home care provided by a hospice and that houses:

2.10 (1) no more than eight hospice patients; or

2.11 (2) at least nine and no more than 12 hospice patients with the approval of the local
2.12 governing authority, notwithstanding section 462.357, subdivision 8.

2.13 (b) Residential hospice facility also means a facility that directly provides 24-hour
2.14 residential and support services for hospice patients and that:

2.15 (1) houses no more than 21 hospice patients;

2.16 (2) meets hospice certification regulations adopted pursuant to title XVIII of the
2.17 federal Social Security Act, United States Code, title 42, section 1395, et seq.; and

2.24 patient's family or other persons caring for the patient. Respite care may be provided
2.25 on an occasional basis."
