2.18 Subd. 2. **Creation of account.** (a) A health professional education loan forgiveness
2.19 program account is established. The commissioner of health shall use money from the
2.20 account to establish a loan forgiveness program:

2.21 (1) for medical residents agreeing to practice in designated rural areas or underserved
2.22 urban communities or specializing in the area of pediatric psychiatry;

2.23 (2) for midlevel practitioners agreeing to practice in designated rural areas or to
2.24 teach at least 12 credit hours, or 720 hours per year in the nursing field in a postsecondary
2.25 program at the undergraduate level or the equivalent at the graduate level;

2.26 (3) for nurses who agree to practice in a Minnesota nursing home or intermediate
2.27 care facility for persons with developmental disability or to teach at least 12 credit hours,
2.28 or 720 hours per year in the nursing field in a postsecondary program at the undergraduate
2.29 level or the equivalent at the graduate level;

2.30 (4) for other health care technicians agreeing to teach at least 12 credit hours, or 720
2.31 hours per year in their designated field in a postsecondary program at the undergraduate
2.32 level or the equivalent at the graduate level. The commissioner, in consultation with
2.33 the Healthcare Education-Industry Partnership, shall determine the health care fields
2.34 where the need is the greatest, including, but not limited to, respiratory therapy, clinical
