## **Bill Description**

Specifies that licenses and registrations granted by the Board of Pharmacy are not transferable. Further, clarifies change of ownership and relocation fees for persons registered with or licensed by the Board of Pharmacy.

#### **Assumptions**

If enacted, this bill will bring clarity and consistency to the way relocation and changes of ownership applications are handled, they will further define when the increased opiate fee of \$5,000 or \$55,000 is assessed, and they will definitively state in statute, that licenses issued by the Board cannot be transferred. If a licensee makes the business decision to relocate the physical location of the person's business or changes its ownership, they must submit an application to the Board. If the licensee already remitted payment for their license during the state's fiscal year, the Board would only charge its operational expense due to the vetting of the application and any onsite inspection. If, however, the application is submitted 60 days prior to the expiration of the license, then the full application fee would be required as this is when the Board opens renewals (60 days prior to a license's expiration). An increase in appropriation is not necessary as changes in ownership and relocation are not regular or cyclical requests. If enacted, Board staff would be able to absorb.

In calendar year 2023, the Board received 19 change of ownership requests (15 non-resident, 4 in-state). Similarly, in 2023, the Board received 36 relocation requests (29 non-resident, 7 in-state).

# **Expenditure and/or Revenue Formula**

Estimates:

25 change-in-ownership or relocations from manufacturers or wholesaler X \$500 (operational fee) = \$12,500

15 change-in-ownership or relocations from pharmacies X \$400 (operational fee) = \$6,000
