1.21 (2) current and valid Minnesota driver's license number ~~or~~ ₂ Minnesota state identification
 1.22 number, ~~or if the voter has no current and valid Minnesota driver's license or Minnesota~~

2.5 (b) A registration application is not deficient due to any of the following:

2.6 (1) the absence of a zip code number does not cause the registration to be deficient;

2.9 (3) the absence of an identification number listed under paragraph (a), clause (2), if the
2.10 voter has not been issued one of those numbers, or the application was accepted before
