Re: Bill Referrals

As of Tuesday, January 22, 2019, the following bills are hereby referred to the Property and Local Tax Division.

HF 24 (Erickson) Reimbursing taxing jurisdictions in Mille Lacs County for lost revenue.

HF 36 (Lueck) Modifying state general tax market value exclusion.

HF 38 (Hertaus) Exempting the first \$200,000 of market value of commercial-industrial property from the state general levy.

HF 75 (Green) Modifying real property transfers of conservation land.

HF 83 (Sundin) Modifying the authority of the city of Cloquet to use revenues from the local sales tax.

HF 97 (Hertaus) Requiring a fractional homestead to be determined based on the percentage of ownership specified in the county land records.

HF 121 (Hertaus) Allowing certain land used to provide environmental benefits to be defined as an agricultural purpose.

HF 144 (Ecklund) Authorizing the city of International Falls to impose a local sales and use tax for specified projects.

HF 175 (Gruenhagen) Modifying requirements for bed and breakfast property.

HF 176 (Stephenson) Modifying tax increment financing authority for the city of Champlin.

HF 183 (Schultz) Modifying Duluth sales and use tax authority

HF 206 (Sundin) Modifying Cloquet Fire and Ambulance District authority to incur debt and impose taxes
