1.14 complaints including information on the Office of Health Facility Complaints and the

1.17 Office of Ombudsman for Mental Health and Developmental Disabilities, Managed Care  
1.18 Ombudsman at the Department of Human Services, county managed care advocates, or

2.12 Subd. 6. **Required annual training.** (a) All staff that perform direct home care services  
2.13 must complete at least eight hours of annual training for each 12 months of employment.  
2.14 The training may be obtained from the home care provider or another source and must  
2.15 include topics relevant to the provision of home care services. The annual training must  
2.16 include:

2.17 (1) training on reporting of maltreatment of minors under section 626.556 and  
2.18 maltreatment of vulnerable adults under section 626.557, whichever is applicable to the  
2.19 services provided;

2.20 (2) review of the home care bill of rights in section 144A.44;

2.21 (3) review of infection control techniques used in the home and implementation of  
2.22 infection control standards including a review of hand-washing techniques; the need for  
2.23 and use of protective gloves, gowns, and masks; appropriate disposal of contaminated  
2.24 materials and equipment, such as dressings, needles, syringes, and razor blades; disinfecting  
2.25 reusable equipment; disinfecting environmental surfaces; and reporting of communicable  
2.26 diseases; and

2.27 (4) review of the provider's policies and procedures relating to the provision of home  
2.28 care services and how to implement those policies and procedures.

2.29 (b) In addition to the topics listed in paragraph (a), annual training may also contain  
2.30 training on providing services to clients with hearing loss. Any training on hearing loss  
2.31 provided under this subdivision must be high quality and research-based, may include online  
2.32 training, and must include training on one or more of the following topics:

3.1 (1) an explanation of age-related hearing loss and how it manifests itself, its prevalence,
