2.2 Subdivision 1. **Order.** The commissioner may issue an order requiring violations to be  
2.3 corrected and administratively assessing monetary penalties for a violation of (1) section  
2.4 221.021; (2) section 221.033, subdivision 2b; (3) section 221.171; (4) section 221.141; (5)  
2.5 a federal, state, or local law, regulation, rule, or ordinance pertaining to railroad-highway  
2.6 grade crossings; or (6) rules of the commissioner relating to the transportation of hazardous  
2.7 waste, motor carrier operations, or insurance, or tariffs and accounting. An order must be  
2.8 issued as provided in this section.
