1.4 Subdivision 1. **Definitions.** For the purposes of this section and section 120B.10, the
1.5 following terms have the meanings given them.

1.6 (a) "Instruction" means methods of providing learning experiences that enable a student
1.7 to meet state and district academic standards and graduation requirements including applied
1.8 and experiential learning.

1.9 (b) "Curriculum" means district or school adopted programs and written plans for
1.10 providing students with learning experiences that lead to expected knowledge and skills
1.11 and career and college readiness.

1.12 (c) "World's best workforce" means striving to: meet school readiness goals; have all
1.13 third grade students achieve grade-level literacy; close the academic achievement gap among
1.14 all racial and ethnic groups of students and between students living in poverty and students
1.15 not living in poverty; have all students attain career and college readiness and participate
1.16 in civics education before graduating from high school; and have all students graduate from
1.17 high school.

1.18 (d) "Experiential learning" means learning for students that includes career exploration
1.19 through a specific class or course or through work-based experiences such as job shadowing,
1.20 mentoring, entrepreneurship, service learning, volunteering, internships, other cooperative
1.21 work experience, youth apprenticeship, or employment.

1.22 (e) "Civics education" means the study of constitutional principles and the democratic
1.23 foundation of our national, state, and local institutions and the study of political processes
1.24 and structures of government, grounded in the understanding of constitutional government
1.25 under the rule of law."
