1.6 home care licensure and are not required to provide the home care bill of rights:

1.7 (1) an individual or business entity providing only coordination of home care that
1.8 includes one or more of the following:

1.9 (i) determination of whether a client needs home care services, or assisting a client
1.10 in determining what services are needed;

1.11 (ii) referral of clients to a home care provider;

1.12 (iii) administration of payments for home care services; or

1.13 (iv) administration of a health care home established under section 256B.0751;

1.14 (2) an individual who is not an employee of a licensed home care provider if the
1.15 individual:

1.16 (i) only provides services as an independent contractor to one or more licensed
1.17 home care providers;

1.18 (ii) provides no services under direct agreements or contracts with clients; and

1.19 (iii) is contractually bound to perform services in compliance with the contracting
1.20 home care provider's policies and service plans;

1.21 (3) a business that provides staff to home care providers, such as a temporary
1.22 employment agency, if the business:

1.23 (i) only provides staff under contract to licensed or exempt providers;

1.24 (ii) provides no services under direct agreements with clients; and

1.25 (iii) is contractually bound to perform services under the contracting home care
1.26 provider's direction and supervision;

2.1 (4) any home care services conducted by and for the adherents of any recognized
2.2 church or religious denomination for its members through spiritual means, or by prayer
2.3 for healing;

2.4 (5) an individual who only provides home care services to a relative;

2.5 (6) an individual not connected with a home care provider that provides assistance
2.6 with basic home care needs if the assistance is provided primarily as a contribution and

2.31 144A.43, subdivision 3: a business trust organized under sections 318.01 to 318.04,

2.33 chapter 323, or any other entity determined by the commissioner;

2.35 equipment, except when the provision of supplies or equipment is accompanied by a

- 3.5 ~~(16)~~ (17) a business that only provides services that are primarily instructional and
- 3.6 not medical services or health-related support services;
- 3.7 ~~(17)~~ (18) an individual who performs basic home care services for no more than
- 3.8 14 hours each calendar week to no more than one client;
- 3.9 ~~(18)~~ (19) an individual or business licensed as hospice as defined in sections 144A.75
- 3.10 to 144A.755 who is not providing home care services independent of hospice service;
- 3.11 ~~(19)~~ (20) activities conducted by the commissioner of health or a community health
- 3.12 board as defined in section 145A.02, subdivision 5, including communicable disease
- 3.13 investigations or testing; or
- 3.14 ~~(20)~~ (21) administering or monitoring a prescribed therapy necessary to control or
- 3.15 prevent a communicable disease, or the monitoring of an individual's compliance with a
- 3.16 health directive as defined in section 144.4172, subdivision 6."
