1.7 equipment incorporated into the construction, remodeling, expansion, or improvement of
1.8 a fire station or police station, including related facilities, owned and operated by a local
1.9 government, as defined under section 297A.70, subdivision 2, paragraph (d), are exempt.

1.10 (b) For purposes of this subdivision, "related facilities" includes access roads, lighting,
1.11 sidewalks, and utility components on or adjacent to the property on which the fire station
1.12 or police station are located that are necessary for safe access to and use of those buildings.

1.13 (c) The tax must be imposed and collected as if the rate under section 297A.62,
1.14 subdivision 1, applied and then refunded in the manner provided in section 297A.75.

3.17 Subd. 2. **Refund; eligible persons.** Upon application on forms prescribed by the
3.18 commissioner, a refund equal to the tax paid on the gross receipts of the exempt items must
3.19 be paid to the applicant. Only the following persons may apply for the refund:

3.20 (1) for subdivision 1, clauses (1), (2), and (14), the applicant must be the purchaser;

3.21 (2) for subdivision 1, clause (3), the applicant must be the governmental subdivision;

3.22 (3) for subdivision 1, clause (4), the applicant must be the recipient of the benefits
3.23 provided in United States Code, title 38, chapter 21;

3.24 (4) for subdivision 1, clause (5), the applicant must be the owner of the homestead
3.25 property;

3.26 (5) for subdivision 1, clause (6), the owner of the qualified low-income housing project;

3.27 (6) for subdivision 1, clause (7), the applicant must be a municipal electric utility or a
3.28 joint venture of municipal electric utilities;
