1.17 the opioid stewardship fund not currently needed shall be credited to the opioid stewardship

3.20 prayer for the treatment or care of disease or remedial care and does not have an attending
3.21 physician, may include a statement appointing an individual who may determine the
3.22 principal's decision-making capacity; and

3.23 (2) a principal who in good faith does not generally select a physician or a health care
3.24 facility for the principal's health care needs may include a statement appointing an individual
3.25 who may determine the principal's decision-making capacity, provided that if the need to
3.26 determine the principal's capacity arises when the principal is receiving care under the
3.27 direction of an attending physician in a health care facility, the determination must be made
3.28 by an attending physician after consultation with the appointed individual.

3.29 If a person appointed under clause (1) or (2) is not reasonably available and the principal
3.30 is receiving care under the direction of an attending physician in a health care facility, an
3.31 attending physician shall determine the principal's decision-making capacity.

3.32 (c) A health care directive may authorize a health care agent to make health care decisions
3.33 for a principal even though the principal retains decision-making capacity.
