I have been praying for you and spoke to many dflers on Tuesday. We agree on everything but the second abortion is brought up the ears close and your party line shut down. This is offensive yet in the wake of such lack of desire to sit and discuss the merits of this proposed legislation or the truth of no restrictions on abortion shows the ignorance and agenda. If there is no agenda to push these bills forth then I would think on an issue such as life and safety for the mothers and child this would not be a hot topic decided over in an hour or 2.

I do not believe HF 1 is the belief of the Majority of Minnesotans.

As you know all amendments we have presented that are common sense measures seem to be hazards to your bill

When one partners with HF1 is ultimately entangling government with the religion of secular humanism conveying to all us that this is the religion majority of Minnesotans identify with and abortion falls into this religion based on supreme court case Torcaso v Watkins that explicitly states government shall not entangle itself with ANY religion. Abortion on basis of convenience is that. Abortion thru birth is murder. No state in the country has such laws, and any such laws are in violation to the oath you and the rest of our govt body took so grandly on Tuesday, January 3, 2023.

I am speaking on behalf of the American ppl and would ask for you to consider this bill, regardless . Thank you. Give voice to the dflers who do not agree with HF 1. Give voice to the mothers who regret abortions after 2 and 3 trimester. Give voice to the 13 year old whose abuser covered the rape and pregnancy by forcing an abortion. Give voice to my grandmother who at 13 years old chose life and never once thought of abortion even though she was born into crisis because of racism in Alabama and was left on a door step. 10 children who grew up over 4th street north. 45 plus grandchildren born. No regrets even though she grew up in complete crisis and the minority as many here discuss that we need to give voice to.

Today because of organization such as Pro Life Action Ministries, my aunts and cousins are alive today because when they decided to abort, the prayers and the literature given along with a source of help and hope were there at the doors of Planned Parenthood and the Robinsdale Women's Clinic (the pro death one) My family rescued from being aborted because that was all our family was told in minneapolis and the POOR Restricted neighborhoods where these death cults are conveniently placed for the sole purposes of preying on the most vulnerable. I know this because this happened to my family. Though some chose life, others did not and I can tell you that there are 10-20 babies dead because some used abortion as birth control.

One aunt of mine raped and on the table at planned parenthood at 14 years old yet "something" told her to get off the table and today my cousin is alive - that is the power of the prayers and sidewalk counselor. For many years I personally counseled and prayed with her as she regretted the choices she made yet again this was the product of one generation and countless lives that did not know THE TRUTH and were targeted because they were minorities, in violence, and on the streets. God help us if we truly allow minors who are vulnerable to have their abusers cover. I know to some extent the pain associated with abuse and covering that. My family knows this as well. Though each story is unique as we have discussed this bill opens the door with no safe guards.

multiple family members have been saved and babies born because cousin alive because of a hug in crisis at the planned parenthood and literature and prayer and he is the best hopscotcher in the world !!!

I am alive after my mother was raped by her stepfather Because my mother got pregnant around that time my mothers birthrights were signed over to my actual biological father to cover up the rape and the possibility that the baby in my mother's womb which was me could have been the product of the rape. My original birth name reflects this thought process and this was just

revealed to me Thanksgiving of this year and I am 41. As mentioned in the public safety committee yesterday, pieces of storylines take years to uncover. Because of the continual stand for life and the ministry that goes forth to all from my heart and what the Lord has called me to and the family he placed me in (all of them) it is moments like this that we can see the devastations of crisis pregnancies in all respects. It is moments like this that I thank God for my life, and for my mother, and my grandmother who endured the worst atrocities as in the ones that many of us have not, yet being the third generation and understanding the value of life, though my pregnancy was in crisis as well — I was determined once I learned that abortion is murder — I determined to change my ways as a young adult. I was determined NOT to walk the same path and to get help when I found myself doing so. I wanted to be the voice of change for my family to give them hope and a future because GOD had opened my eyes to this as I studied the Purpose Driven Life by Rick Warren. You see, I did not grow up with the WORD of God nor did I have a relationship with Jesus. But when he found me, this love was like none other and my eyes opened to TRUTH. To every person who reads this and every person who has endured — God loves you and is for you and you were not an accident. The things that took place in your life and the pain and suffering with the Word of God applied changes everything even perspectives such as the issue of LIFE.

My mother when told my grandma that she was pregnant was sent away with my birth father. I was put at risk of being taken away by the state because my birth father was older yet he rescued my mother from being homeless on the street and from heard her story. When I met him he told me that he was kicked to the curb, and that Pammy my mom got serious about life. She had a future hope now. My biological father knew he couldn't be in my life, signed my birth papers over to the dad that adopted me at one. That decision was also the best as this man would care for my mom and I. I did not know he was not my birth father until I was 10. That was found out by accident as I found my mom's journal . I was either 10, or 12 — that was difficult but curiosity got the best of me on who this man was and at 24 by the grace of God we met.

And so my mother chose life for me and an unwed mothers home near governors mansion cared for her.

I chose life for my son in the midst of crisis. Abortion did not cross my mind. I married and paid the price of being with a man who did not honor my life. I wanted my son to know Jesus and have a father. Though our divorced finalized about a yr ago, and what i went through was brutal in that divorce, because as we know the behind the scenes of court cases is not always easy...

I chose to call upon the resources available and the extreme differences compromised just as you have the opportunity to for millions — and millions of babies to come.

I believe there are thousands of mothers and fathers who need the life resources rather than abort and of course you know I believe and the majority of us would believe who are in opposition of such extreme bills like HF 1 that Convenience abortions are wrong

Because the father is not around

We have solutions to those issues. Purity and abstinence are the answer to unplanned pregnancy.

Rape, incest, ectopic pregnancies, and mother medical emergencies listed in bill language here are secular and do not entangle govt in secular humanism religion which convenience abortions fall under. I understand the law. I understand the moving parts as well.
