1.7 An amendment to the Minnesota Constitution is proposed to the people. If the amendment  
1.8 is adopted, a section shall be added to article XIV, to read:

1.9 Sec. 14. Beginning April 1, 2020, the motor fuel excise tax under section 10 shall be  
1.10 increased incrementally. Beginning January 1, 2022, the tax rate for E85 must not be lower  
1.11 than 31.95 cents per gallon, the tax rate for M85 must not be lower than 25.65 cents per  
1.12 gallon, and the tax rate for all other gasoline must not be lower than 45 cents per gallon.

1.13 EFFECTIVE DATE. This section is effective the day following final enactment.

1.14 Sec. 2. SUBMISSION TO VOTERS.

1.15 (a) The proposed amendment under section 1 must be submitted to the people at a special  
1.16 election to be held by November 1, 2019. The question submitted must be:

1.17 "Shall the Minnesota Constitution be amended to increase the gasoline tax by 20 cents  
1.18 per gallon?

1.19 Yes .....

1.20 No ....."
