#### **BWSR Soil Health Practices Program** Climate Action Framework – Fiscal and Policy Request (\$27.16M)




- Establishes a voluntary and locally-driven Soil Health Practices Program (new 103F).
- Sets practices on sensitive lands to slow water and nutrient movement.
- Provides for carbon sequestration.
- Opportunity for federal matching dollars (103C)

## Accelerated Water Storage Program

Climate Action Framework - Fiscal Request (\$17M)



- Adapt to changing climate
- Acquire, design, and construct projects to control water volume and rate
- Voluntary and locally-led



#### Habitat Enhancement Landscape Program (HELP) Climate Action Framework – Fiscal and Policy Request (\$4M)



- Building on a current program, offers cost-share grants and technical guidance for projects on lands that are a priority for the protection of endangered or threatened pollinators and other wildlife species.
- Eligible lands include existing natural areas, conservation plantings, and open spaces.

#### HELP – Habitat Friendly Utilities Climate Action Framework – Fiscal and Policy Request (\$1M)



 Building on a current program, provides financial and technical assistance to promote the successful establishment of native vegetation as part of utility projects including solar, wind, pipelines and electrical transmission corridors to ensure the integrity and resiliency of Minnesota landscapes and protection of habitat and water resources.

#### HELP – Lawns to Legumes Climate Action Framework – Fiscal and Policy Request (\$4M)



- This award-winning program offers a combination of workshops, coaching, planting guides and cost-share funding (individual support grants) for installing pollinatorfriendly native plantings in residential lawns and community spaces.
- Over 17,000 applications received for individual grants across the state; approximately 12,000 applications waiting additional program funding.




