1.6 Subd. 3. **Jurisdiction; general.** (a) Except as provided in subdivisions 4 and 5, the
1.7 conciliation court has jurisdiction to hear, conciliate, try, and determine civil claims if the
1.8 amount of money or property that is the subject matter of the claim does not exceed: (1)
1.9 ~~\$7,500; (2) \$4,000; \$10,000 or \$5,000~~ if the claim involves a consumer credit transaction;
1.10 or ~~(3)~~ (2) \$15,000, if the claim involves money or personal property subject to forfeiture
1.11 under section 609.5311, 609.5312, 609.5314, or 609.5318. "Consumer credit transaction"
1.12 means a sale of personal property, or a loan arranged to facilitate the purchase of personal
1.13 property, in which:

1.14 (1) credit is granted by a seller or a lender who regularly engages as a seller or
1.15 lender in credit transactions of the same kind;

1.16 (2) the buyer is a natural person;

1.17 (3) the claimant is the seller or lender in the transaction; and

1.18 (4) the personal property is purchased primarily for a personal, family, or household
1.19 purpose and not for a commercial, agricultural, or business purpose.

1.20 (b) Except as otherwise provided in this subdivision and subdivisions 5 to 10, the
1.21 territorial jurisdiction of conciliation court is coextensive with the county in which the
1.22 court is established. The summons in a conciliation court action under subdivisions 6 to
1.23 10 may be served anywhere in the state, and the summons in a conciliation court action
1.24 under subdivision 7, paragraph (b), may be served outside the state in the manner provided
1.25 by law. The court administrator shall serve the summons in a conciliation court action
1.26 by first class mail, except that if the amount of money or property that is the subject of
1.27 the claim exceeds \$2,500, the summons must be served by the plaintiff by certified mail,

2.1 and service on nonresident defendants must be made in accordance with applicable law
 2.2 or rule. Subpoenas to secure the attendance of nonparty witnesses and the production of
 2.3 documents at trial may be served anywhere within the state in the manner provided by law.

2.4 When a court administrator is required to summon the defendant by certified mail
 2.5 under this paragraph, the summons may be made by personal service in the manner
 2.6 provided in the Rules of Civil Procedure for personal service of a summons of the district
 2.7 court as an alternative to service by certified mail.

2.8 **EFFECTIVE DATE.** This section is effective August 1, 2011, and applies to claims
 2.9 filed on or after that date.

2.10 Sec. 2. **[540.19] CLASS ACTIONS; INTERLOCUTORY APPEAL.**

2.11 A court order certifying a class action, refusing to certify a class action, or denying a
 2.12 motion to decertify a class action is appealable as a matter of right. While an appeal under
 2.13 this subdivision is pending, all discovery and other proceedings in the district court are
 2.14 automatically stayed, except that upon the motion of a party the district court may lift the
 2.15 stay, in whole or in part, for good cause shown.
