

Historical Overview

- Duluth State Veterans Cemetery (SVC) (NE MN) pre-application submitted to the Federal Veterans Cemetery Grant Program (VCGP)
 - 2008 MN Legislature directed MDVA to come back in 2009 and present information regarding SVCs in Southern MN
- MN Session Law Authorized MDVA to develop projects to build new SVCs in NE & SW MN; appropriated \$1.5M for design/property acquisition
 - SW MN project submitted to VCGP to be included on National Cemetery Administration's (NCA) Priority List
- Commitment of land from Fillmore County for a Preston SVC (SE MN); Preston SVC project pre-application submitted to the VCGP
- MN Session Law amended to include development of the Preston SVC in SE MN
- Preston SVC (SE MN) offered a grant opportunity from the VCGP and began design and development
- Duluth SVC (NE MN) offered a grant opportunity from the VCGP and began design and development
 - Preston SVC (SE MN) opened November 2015
- 2018 Duluth SVC (NE MN) opened November 2018
- Redwood Falls SVC (SW MN) offered a grant opportunity from the VCGP and began design and development
- The 2021 Minnesota Legislature appropriated \$4.5M to assist with the development and equipment costs for establishing the Redwood Falls SVC (SW MN)
- Redwood Falls SVC (SW MN) opened August 2023

MDVA's Request

- Legislative authority to:
 - Allow MDVA to submit a pre-application for a grant to fund construction to the VA's National Cemetery Administration (NCA)
 - Begin site search activities
- We are not seeking funding
 - Future funding requests will allow MDVA to submit a formal application for federal Veterans Cemetery Grant Program (VCGP) funding



Proposed New SVC Location

Current Status:

- National Cemetery Administration (NCA) Strategic Goal: Provide 95% of Veterans with a burial option within 75 miles of their home
- NCA operates one National Cemetery (Ft Snelling) in Minnesota and some areas of western Minnesota are also served by the National Cemetery located in Fargo, North Dakota
- State of Minnesota currently operates four State Veterans Cemeteries (SVC) in Duluth, Little Falls, Preston, and Redwood Falls
- The NCA confirmed during the Fall 2021 National Association of State Directors of Veterans Affairs conference that there is a targeted gap in northerwestern Minnesota within the network of national and state veterans cemeteries

Proposal:


- Issue: Unserved area in northwestern Minnesota, with over 10,000 "underserved" Veterans, per NCA Strategic Goal standards
- Criteria: sufficient acreage, representative of the geographical region, and easy access for the served population
- Tribal Nation Impact: Leech Lake Tribal government operates a small Tribal Veterans Cemetery in Cass Lake. The Red Lake Nation, the White Earth Nation, and the Bois Forte Band of Chippewa are also within the catchment area



Potential Locations



- This map shows a 15 mile radius from downtown Bemidji and the preferred area in which a State Veterans Cemetery would be located
 Ideal sites would:
- Be city, county or state-owned lands to reduce land acquisition costs. There are several state-owned land options
- Represent the region it serves:
 - $\circ\,$ Wooded lot
 - Incorporate water features if possible
- Near Bemidji (within 15 mi) for workforce pool
- Direct access to a state or county highway
- 60-120 acres
- Direct access or close access to public utilities
- Provide tranquil setting (i.e. avoiding heavily trafficked areas and airports)

Potential Locations



- This map shows all the different State School Trust Lands currently managed by the DNR
- MDVA would seek a similar arrangement to the establishment of the Duluth SVC, where State School Trust Land was provided
- Note: each square is roughly equivalent to 40 acres. Ideally looking for 80-120 acres
