1.7 or from waters of the state for hire or as a service provided as a benefit of membership in a
1.8 yacht club, boat club, marina, or similar organization; or

1.9 (2) rents or leases water-related equipment that will be used in, placed into, or
1.10 removed from waters of the state.

1.11 Service provider does not include a person working under the supervision of an individual
1.12 with a valid service provider permit issued under section 84D.108.

1.13 Sec. 7. Minnesota Statutes 2012, section 84D.03, subdivision 4, is amended to read:

1.14 Subd. 4. **Commercial fishing and turtle, frog, and crayfish harvesting**
1.15 **restrictions in infested and noninfested waters.** (a) All nets, traps, buoys, anchors,
1.16 stakes, and lines used for commercial fishing or turtle, frog, or crayfish harvesting in
1.17 an infested water that is designated because it contains invasive fish, invertebrates, or
1.18 certifiable diseases, as defined in section 17.4982, may not be used in any other waters.
1.19 If a commercial licensee operates in an infested water designated because it contains
1.20 invasive fish, invertebrates, or certifiable diseases, as defined in section 17.4982, all nets,
1.21 traps, buoys, anchors, stakes, and lines used for commercial fishing or turtle, frog, or
1.22 crayfish harvesting in waters designated as infested with invasive fish, invertebrates, or
1.23 certifiable diseases, as defined in section 17.4982, must be tagged with tags provided by
1.24 the commissioner, as specified in the commercial licensee's license or permit. This tagging
1.25 requirement does not apply to commercial fishing equipment used in Lake Superior.

2.1 (b) All nets, traps, buoys, anchors, stakes, and lines used for commercial fishing or
 2.2 turtle, frog, or crayfish harvesting in an infested water that is designated solely because it
 2.3 contains Eurasian water milfoil must be dried for a minimum of ten days or frozen for a
 2.4 minimum of two days before they are used in any other waters, except as provided in this
 2.5 paragraph. Commercial licensees must notify the department's regional or area fisheries
 2.6 office or a conservation officer before removing nets or equipment from an infested water
 2.7 designated solely because it contains Eurasian water milfoil and before resetting those nets
 2.8 or equipment in any other waters. Upon notification, the commissioner may authorize a
 2.9 commercial licensee to move nets or equipment to another water without freezing or drying,
 2.10 if that water is designated as infested solely because it contains Eurasian water milfoil.

2.18 Subdivision 1. **Transportation prohibited.** Unless specifically authorized under

 2.20 macrophytes, except as provided in this section.

2.21 Subd. 2. **Exceptions.** Unless otherwise prohibited by law, a person may transport
 2.22 aquatic macrophytes:

3.10 Subdivision 1. **Launching prohibited.** A person may not place or attempt to place
3.11 into waters of the state water-related equipment, including aquatic plant harvesting or
3.12 control equipment that has aquatic macrophytes, ~~zebra mussels~~, or prohibited invasive
3.13 species attached except as provided in this section.

3.14 Sec. 10. Minnesota Statutes 2012, section 84D.10, subdivision 4, is amended to read:

3.15 Subd. 4. **Persons transporting water-related equipment.** (a) When leaving waters
3.16 of the state a person must drain water-related equipment holding water and live wells and
3.17 bilges by removing the drain plug before transporting the water-related equipment off
3.18 the water access site or riparian property.

3.19 (b) Drain plugs, bailers, valves, or other devices used to control the draining of water
3.20 from ballast tanks, bilges, and live wells must be removed or opened while transporting
3.21 water-related equipment.

3.22 (c) Emergency response vehicles and equipment may be transported on a public road
3.23 with the drain plug or other similar device replaced only after all water has been drained
3.24 from the equipment upon leaving the water body.

4.7 Subd. 2. **Inspector authority.** (a) The commissioner shall train and authorize
4.8 individuals to inspect water-related equipment for aquatic macrophytes, aquatic invasive
4.9 species, and water. The commissioner may enter into a delegation agreement with a
4.10 tribal or local government where inspection authority as provided under paragraphs (b),
4.11 (g), and (h) is delegated to tribal and local governments that assume all legal, financial,
4.12 and administrative responsibilities for inspection programs on some or all public waters
4.13 within their jurisdiction.

4.14 (b) Inspectors may visually and tactilely inspect watercraft and water-related
4.15 equipment to determine whether aquatic invasive species, aquatic macrophytes, or water
4.16 is present. If a person transporting watercraft or water-related equipment refuses to
4.17 take required corrective actions or fails to comply with an order under section 84D.10,
4.18 subdivision 3, an inspector who is not a licensed peace officer shall refer the violation

4.20 (c) In addition to paragraph (b), a conservation officer or other licensed peace officer

4.24 that aquatic invasive species, aquatic macrophytes, or water is present on the watercraft or
4.25 water-related equipment.

4.26 (d) Conservation officers or other licensed peace officers may utilize check stations
4.27 in locations, or in proximity to locations, where watercraft or other water-related
4.28 equipment is placed into or removed from waters of the state. Any check stations shall be
4.29 operated in a manner that minimizes delays to vehicles, equipment, and their occupants.

4.30 (e) Conservation officers or other licensed peace officers may order water-related
4.31 equipment to be removed from a water body if the commissioner determines such action is
4.32 needed to implement aquatic invasive species control measures.

4.33 (f) The commissioner may require mandatory inspections of water-related equipment
4.34 before a person places or removes water-related equipment into or out of a water body.
4.35 Inspection stations may be located at or near public water accesses or in locations that

5.7 (4) have decontamination equipment available to bring water-related equipment

5.9 (5) do not reduce the capacity or hours of operation of public water accesses.

5.11 a delegation agreement with the commissioner to conduct mandatory inspections of
5.12 water-related equipment at specified locations within a defined area before a person
5.13 places or removes water-related equipment into or out of a water body. Tribal and local
5.14 governments that are authorized to conduct inspections under this paragraph must:

5.15 (1) assume all legal, financial, and administrative responsibilities for implementing
5.16 the mandatory inspections, alone or in agreement with other tribal or local governments;

5.17 (2) employ inspectors that have been trained and authorized by the commissioner;

5.18 (3) conduct inspections and decontamination measures in accordance with guidelines
5.19 approved by the commissioner;

5.21 alternative decontamination equipment locations within a reasonable distance of the
5.22 inspection station that can bring water-related equipment into compliance;

5.28 do not discourage or limit use;

5.31 at inspection stations and public accesses;

5.32 (4) adequate enforcement capacity;

5.33 (5) measures to address inspections of water-related equipment at public water
