1.8 has not been within this state for more than 90 consecutive days, which does not include  
1.9 days that a watercraft is laid up at dock over winter or for repairs at a Lake Superior  
1.10 port or another port in the state;

1.11 (2) a watercraft from a country other than the United States that has not been within  
1.12 this state for more than 90 consecutive days, which does not include days that a watercraft is  
1.13 laid up at dock over winter or for repairs at a Lake Superior port or another port in the state;

1.15 a political subdivision of a state, except watercraft used for recreational purposes;

1.17 (5) a watercraft that has been issued a valid marine document by the United States

1.19 (6) a duck boat during duck hunting season;

1.20 (7) a rice boat during the harvest season;

1.21 (8) a seaplane; and

1.22 (9) a nonmotorized watercraft ten feet in length or less, except for canoes and kayaks  
1.23 five feet in length or greater.
