1.5 Subdivision 1. **Amounts.** (a) The department must be paid the following fees:

1.6 (1) for filing an application for and the issuance of an original certificate of title, the
1.7 sum of \$6.25 of which \$3.25 must be paid into the vehicle services operating account of
1.8 the special revenue fund under section 299A.705; until June 30, ~~2012~~ 2015, a surcharge of
1.9 \$1.75 must be added to the fee and credited to the driver and vehicle services technology
1.10 account;

1.11 (2) for each security interest when first noted upon a certificate of title, including the
1.12 concurrent notation of any assignment thereof and its subsequent release or satisfaction,

1.20 (4) for each assignment of a security interest when first noted on a certificate of title,
1.21 unless noted concurrently with the security interest, the sum of \$1;

1.22 (5) for issuing a duplicate certificate of title, the sum of \$7.25 of which \$3.25 must
1.23 be paid into the vehicle services operating account of the special revenue fund under
1.24 section 299A.705; until June 30, ~~2012~~ 2015, a surcharge of \$1.75 must be added to the fee
1.25 and credited to the driver and vehicle services technology account.
