4.8 (a) The office shall have the authority to terminate a postsecondary institution's
4.9 eligibility to participate in state student aid programs if the institution meets one of the
4.10 following criteria:

4.11 (1) violates a provision of Minnesota Statutes, Minnesota Rules, or administrative
4.12 policies governing student aid programs and fails to correct the violation and reimburse
4.13 the office for audit findings within the time frame specified in the audit report or other
4.14 notice furnished by the office;

4.15 (2) has a consistent pattern of noncompliance with Minnesota Statutes, Minnesota
4.16 Rules, or administrative policies governing student aid programs as documented by the
4.17 office or lacks administrative capability to successfully administer student financial aid
4.18 programs on campus based on factors including, but not limited to:

4.19 (i) adequacy of financial aid staffing levels, experience, training, and turnover of key
4.20 financial aid staff;

4.21 (ii) adequate checks and balances in its system of internal controls;

4.22 (iii) maintenance of records required for programs; or

4.25 (3) refuses to allow inspection of or provide information relating to financial aid

5.5 The office shall provide written notice of its intent to terminate an institution's
5.6 eligibility to participate in student financial aid programs if the institution meets any of
5.7 the criteria for termination in section 136A.104. The office shall send the institution
5.8 written notification of the termination which is effective 90 days from the date of the
5.9 written notification. The office shall also provide an institution an opportunity for a
5.10 hearing pursuant to chapter 14.

5.11 **Sec. 5. [136A.1042] REQUEST FOR HEARING.**

5.12 An institution may request a hearing pursuant to chapter 14 regarding its termination
5.13 of eligibility to participate in a student aid program. The request must be in writing and
5.14 must be received by the director within 30 days of the date on the written notification of
5.15 termination sent by the office. Within ten days of receipt of the request for hearing, the
5.16 office shall contact the Office of Administrative Hearings to arrange a hearing date.

5.18 **PERIOD.**

5.19 After the notice of termination and until such time as the termination becomes
5.20 effective, the office reserves the right to withhold further financial aid disbursements to the
5.21 institution. During this period, the institution may not make any new awards to students
5.22 but may use any remaining student aid program funds on campus to make disbursements
5.23 to any students awarded funds prior to the notice of termination.

5.24 **Sec. 7. [136A.1044] FINAL DECISION, ORDERS.**

5.25 The director shall render a decision and order in writing following receipt of the
5.26 report issued by the administrative law judge after the hearing. The final decision of the
5.27 director shall take into consideration the hearing record and the report of the administrative
5.28 law judge. The order of the director is the final decision in the termination of the
5.29 institution's eligibility to participate in a student aid program administered by the office.

6.1 An institution terminated from participating in student financial aid programs
6.2 may submit a request for reinstatement of eligibility. The institution must wait at least
6.3 12 consecutive months from the effective date of the termination to submit a request
6.4 for reinstatement. A request for reinstatement must be in writing and submitted to the
6.5 director. If the institution is initially denied reinstatement, the institution must wait at
6.6 least 90 days from the date of denial of reinstatement to resubmit a subsequent request
6.7 for reinstatement. If an institution's eligibility is reinstated after the start of the academic
6.8 term, eligible students shall receive payment retroactively to the beginning of the term
6.9 during which the institution was reinstated.

6.10 **Sec. 9. [136A.1046] REINSTATEMENT REQUIREMENTS.**

6.11 An institution's reinstatement request must include:

- 6.12 (1) written documentation specifying changes the institution has made to
6.13 successfully address the reasons for termination, as outlined in the termination notice;
6.14 (2) permission for the office's staff to conduct a reinstatement audit and to evaluate
6.15 systems put in place to address the reasons for termination;
6.16 (3) evidence of full repayment to the office of student aid program funds the
6.17 institution improperly received, withheld, disbursed, or caused to be disbursed;
6.18 (4) new participation agreements with the office for all student aid programs in
6.19 which the institution wishes to participate; and
6.20 (5) if applicable, documentation of the institution's eligibility to participate in
6.21 federal financial aid programs.

6.22 **Sec. 10. [136A.1047] RESPONSE TO REINSTATEMENT REQUEST.**

6.23 Within 60 days of receiving the institution's reinstatement request, the office shall
6.24 conduct a reinstatement audit and either:

- 6.25 (1) place the institution on probationary status for a period of one year; or
6.26 (2) deny the request based on the institution meeting one or more of the termination
6.27 criteria in section 136A.104.

6.28 **Sec. 11. [136A.1048] PROBATIONARY PERIOD.**

7.12 termination, the office must issue a payment for that payment period, as long as the student
7.13 will not receive a payment for the same payment period from another institution and the
