1.7 62D, 62E, and 62H, section 471.617, subdivisions 2 and 3, and the bidding requirements of
1.8 section 471.6161. The public employee insurance program must follow the requirements
1.9 of section 471.6161, subdivision 8, paragraphs (a) and (c).

1.12 Subd. 11. **Proposal from school district; response required.** Upon receipt of a

1.14 the public employees insurance program shall respond to such request within 60 days.

1.15 Sec. 3. Minnesota Statutes 2012, section 123A.21, subdivision 5, is amended to read:

1.16 Subd. 5. **Duties and powers of SC board of directors.** The board of directors shall
1.17 have authority to maintain and operate a SC. Subject to the availability of necessary
1.18 resources, the powers and duties of this board shall include the following:

1.19 (a) The board of directors shall submit, by June 1 of each year to each participating
1.20 member, an annual plan which describes the objectives and procedures to be implemented
1.21 in assisting in resolution of the needs of the SC.

1.22 (b) The SC board of directors shall provide adequate office, service center, and
1.23 administrative facilities by lease, purchase, gift, or otherwise.

1.24 (c) The SC board of directors shall employ a central administrative staff and other
1.25 personnel as necessary to provide and support the agreed-upon programs and services.

2.1 The board may discharge staff and personnel pursuant to applicable provisions of law.
2.2 SC staff and personnel may participate in retirement programs and any other programs

2.4 (d) The SC board of directors may appoint special advisory committees composed

2.7 committees are considered a committee of a public body for purposes of section 13D.01,
2.8 subdivision 1, paragraph (c), when addressing issues related to health insurance.

2.9 (e) The SC board of directors may employ service area personnel pursuant to
2.10 licensure and certification standards developed by the appropriate state agency such as the
2.11 commissioner and the State Board of Teaching.

2.12 (f) The SC board of directors may enter into contracts with school boards of local
2.13 districts including school districts outside the SC area.

2.14 (g) The SC board of directors may enter into contracts with other public and private
2.15 agencies and institutions to provide administrative staff and other personnel as necessary
2.16 to furnish and support the agreed-upon programs and services.

2.17 (h) The SC board of directors shall exercise all powers and carry out all duties
2.18 delegated to it by members under provisions of the SC bylaws. The SC board of directors

2.27 Subd. 6. **Appointment of advisory council.** There may be advisory councils
2.28 selected to give advice and counsel to the SC board of directors. The councils may be
2.29 composed of representatives from public and nonpublic schools, cities, counties, and other
2.30 governmental units. The advisory councils are considered to be a committee of a public
2.31 body for purposes of section 13D.01, subdivision 1, paragraph (c), when addressing
2.32 issues related to health insurance.

2.33 Sec. 5. Minnesota Statutes 2012, section 123B.09, subdivision 12, is amended to read:

3.1 Subd. 12. **Board to fix compensation.** The clerk, treasurer, and superintendent
3.2 of any district shall receive such compensation as may be fixed by the board. Unless
3.3 otherwise provided by law, the other members of the board shall also receive such
3.4 compensation as may be fixed by the board. All members of the board may receive
3.5 reimbursement for transportation at the rate provided for in section 471.665. No board
3.6 member or school district employee shall receive any compensation or benefits based on
3.7 incentives or other money provided to the school district by or from a source of group
3.8 insurance coverage referenced in section 471.6161, subdivision 1, except for a refund

3.12 Subd. 10. **Insurance premium rebates.** (a) If monies collected by an entity

3.14 insurance premiums are above the cost of that coverage and returned to the school district
3.15 purchasing that coverage as a refund, that school district must negotiate with the exclusive
3.16 representative regarding the refund amount attributable to the proportionate number of
3.17 insured lives covered by that exclusive representative.

3.18 (b) If there is no exclusive representative or if the employer and the exclusive
3.19 representative are unable to come to an agreement within 150 days, the remaining refunds

4.12 A violation of this prohibition renders the contract void.

4.13 (c) Any employee, agent, or board member of the authorizer who participates
4.14 in the initial review, approval, ongoing oversight, evaluation, or the charter renewal or
4.15 nonrenewal process or decision is ineligible to serve on the board of directors of a school
4.16 chartered by that authorizer.

4.17 (d) An individual may serve as a member of the board of directors if no conflict of
4.18 interest under paragraph (a) exists.

4.19 (e) The conflict of interest provisions under this subdivision do not apply to
4.20 compensation paid to a teacher employed as a teacher by the charter school or a teacher
4.21 who provides instructional services to the charter school through a cooperative formed
4.22 under chapter 308A when the teacher also serves on the charter school board of directors.

4.23 (f) A charter school board member, employee, or officer must not accept gifts as
4.24 defined under section 10A.071, subdivision 1, paragraph (b), and must not request another
4.25 person to give a gift to a board member, employee, or officer. A board member, employee,
4.26 or officer must not receive compensation from a group health insurance provider.

4.29 Subd. 11. **Employment and other operating matters.** (a) A charter school must
4.30 employ or contract with necessary teachers, as defined by section 122A.15, subdivision 1,
4.31 who hold valid licenses to perform the particular service for which they are employed in
4.32 the school. The charter school's state aid may be reduced under section 127A.43 if the
4.33 school employs a teacher who is not appropriately licensed or approved by the board of
4.34 teaching. The school may employ necessary employees who are not required to hold

5.19 related to the operation of the school, including budgeting, curriculum programming,
5.20 personnel, and operating procedures. The board shall adopt a policy on nepotism in
5.21 employment. The board shall adopt personnel evaluation policies and practices that,
5.22 at a minimum:

- 5.23 (1) carry out the school's mission and goals;
- 5.24 (2) evaluate the execution of charter contract goals and commitments;
- 5.25 (3) evaluate student achievement, postsecondary and workforce readiness, and

5.30 of licensed teachers providing instruction under a contract between a school and a

5.32 (1) request proposals for group health insurance coverage from a minimum of three
5.33 sources at least every two years; and

5.34 (2) notify employees covered by the group health insurance coverage before the

 6.2 coverage must establish and publish on its Web site the policy for the purchase of group

 6.14 purposes of chapter 179A, upon formation of one or more bargaining units at the school.
 6.15 Bargaining units at the school must be separate from any other units within an authorizing

7.9 (b) School districts shall request proposals for group health insurance coverage as

7.11 of these requests must go to an administrator governed by chapter 43A. School districts
7.12 opting for self-insurance must also follow these provisions. School districts must make
