1.14 shall develop a uniform method of calculating providers' relative cost of care, defined as a
1.15 measure of health care spending including resource use and unit prices, and relative quality
1.16 of care. In developing this method, the commissioner must address the following issues:

- 1.17 (1) provider attribution of costs and quality;
- 1.18 (2) appropriate adjustment for outlier or catastrophic cases;
- 1.19 (3) appropriate risk adjustment to reflect differences in the demographics and health
1.20 status across provider patient populations, using generally accepted and transparent risk
1.21 adjustment methodologies and case mix adjustment;
- 1.22 (4) specific types of providers that should be included in the calculation;
- 1.23 (5) specific types of services that should be included in the calculation;
- 1.24 (6) appropriate adjustment for variation in payment rates;
- 1.25 (7) the appropriate provider level for analysis;

2.1 (8) payer mix adjustments, including variation across providers in the percentage of
2.2 revenue received from government programs; and

2.3 (9) other factors that the commissioner ~~determines~~ and the advisory committee,
2.4 established under subdivision 3, determine are needed to ensure validity and comparability

2.15 ~~system, the commissioner shall consult and coordinate with health care providers, health~~
2.16 ~~plan companies, state agencies, and organizations that work to improve health care quality~~
2.17 ~~in Minnesota.~~ For purposes of the final establishment of the peer grouping system, the
2.18 commissioner shall not contract with any private entity, organization, or consortium of
