1.10 issued valid license from another state, or ~~is enrolled in either:~~

1.11 (i) the applicant is enrolled in behind-the-wheel training in a public, private, or  
1.12 commercial driver education program that utilizes simulation or behind-the-wheel  
1.13 instruction and that is approved by the commissioner of public safety; and

1.14 (ii) the applicant:

1.15 (A) has successfully completed the classroom phase of instruction in a public,  
1.16 private, or commercial driver education program that is approved by the commissioner of  
1.17 public safety and that includes classroom and behind-the-wheel training; or,

1.19 (B) has successfully completed homeschool driver training, when the student

2.22 (b) For the purposes of determining compliance with the certification of paragraph  
2.23 (a), clause (1), item (ii), subitem (B), the commissioner may request verification of a  
2.24 student's homeschool status from the superintendent of the school district in which the  
2.25 student resides and the superintendent shall provide that verification.

2.26 (c) The instruction permit is valid for two years from the date of application and  
2.27 may be renewed upon payment of a fee equal to the fee for issuance of an instruction  
2.28 permit under section 171.06, subdivision 2.

3.23 In addition to each fee required in this paragraph, the commissioner shall collect a  
 3.24 surcharge of: (1) \$1.75 until June 30, 2012; and (2) \$1.00 from July 1, 2012, to June 30,  
 3.25 2016. Surcharges collected under this paragraph must be credited to the driver and vehicle  
 3.26 services technology account in the special revenue fund under section 299A.705.

3.27 (b) Notwithstanding paragraph (a), an individual who holds a provisional license and  
 3.28 has a driving record free of (1) convictions for a violation of section 169A.20, 169A.33,  
 3.29 169A.35, or sections 169A.50 to 169A.53, (2) convictions for crash-related moving  
 3.30 violations, and (3) convictions for moving violations that are not crash related, shall have a  
 3.31 \$3.50 credit toward the fee for any classified under-21 driver's license. "Moving violation"  
 3.32 has the meaning given it in section 171.04, subdivision 1.

3.33 (c) In addition to the driver's license fee required under paragraph (a), the  
 3.34 commissioner shall collect an additional \$4 processing fee from each new applicant  
 3.35 or individual renewing a license with a school bus endorsement to cover the costs for  
 3.36 processing an applicant's initial and biennial physical examination certificate. The  
 3.37 department shall not charge these applicants any other fee to receive or renew the  
 3.38 endorsement.

3.39 (d) In addition to the fee required under paragraph (a), a driver's license agent may  
 3.40 charge and retain a filing fee as provided under section 171.061, subdivision 4.

3.41 (e) In addition to the fee required under paragraph (a), the commissioner shall  
 3.42 charge a filing fee at the same amount as a driver's license agent under section 171.061,

4.3 (f) An application for a Minnesota identification card, instruction permit, provisional  
4.4 license, or driver's license, including an application for renewal, must contain a provision  
4.5 that allows the applicant to add to the fee under paragraph (a), a \$2 donation for the  
4.6 purposes of public information and education on anatomical gifts under section 171.075.

4.7 (g) In addition to the instruction permit fee required under paragraph (a), the  
4.8 commissioner shall collect an additional \$5 program implementation fee from an applicant  
4.9 who is enrolled in concurrent driver education instruction as provided in section 171.05,  
4.10 subdivision 2, paragraph (a), clause (1), item (ii), subitem (C). The commissioner shall  
4.11 terminate the fee under this paragraph when the department has fully recovered its  
4.12 costs to implement concurrent classroom phase and behind-the-wheel instruction under  
4.13 section 171.05. The commissioner shall deposit proceeds of the fee in the driver services  
4.14 operating account in the special revenue fund. Proceeds from the fee under this paragraph  
4.15 are annually appropriated to the commissioner from the driver services operating account  
4.16 for administrative costs to implement concurrent driver education."
