 1.19 and monitoring research, and water access

3.3 enhancement account in the game and

3.7 \$1,223,000 the first year and \$1,223,000 the  
3.8 second year are from the nongame wildlife  
3.9 management account in the natural resources  
3.10 fund for the purpose of nongame wildlife  
3.11 management. Notwithstanding Minnesota  
3.12 Statutes, section 290.431, \$100,000 the first  
3.13 year and \$100,000 the second year may  
3.14 be used for nongame wildlife information,  
3.15 education, and promotion.

3.16 \$1,600,000 the first year and \$6,000,000 the  
3.17 second year are from the general fund for the  
3.18 following activities:

3.19 (1) increased financial reimbursement  
3.20 and technical support to soil and water  
3.21 conservation districts or other local units  
3.22 of government for groundwater level  
3.23 monitoring;

3.24 (2) additional surface water monitoring and  
3.25 analysis, including installation of monitoring  
3.26 gauges;

3.27 (3) additional groundwater analysis to  
3.28 assist with water appropriation permitting  
3.29 decisions;

3.30 (4) additional permit application review  
3.31 incorporating surface water and groundwater  
3.32 technical analysis;
