1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2022, section 624.7131, is amended to read:
1.8	624.7131 TRANSFEREE PERMIT; PENALTY.
1.9	Subdivision 1. Information. Any person may apply for a transferee permit by providing
1.10	the following information in writing to the chief of police of an organized full time police
1.11	department of the municipality in which the person resides or to the county sheriff if there
1.12	is no such local chief of police:
1.13	(1) the name, residence, telephone number, and driver's license number or
1.14	nonqualification certificate number, if any, of the proposed transferee;
1.15	(2) the sex, date of birth, height, weight, and color of eyes, and distinguishing physical
1.16	characteristics, if any, of the proposed transferee;
1.17	(3) a statement that the proposed transferee authorizes the release to the local police
1.18	authority of commitment information about the proposed transferee maintained by the
1.19	commissioner of human services, to the extent that the information relates to the proposed
1.20	transferee's eligibility to possess a pistol or semiautomatic military-style assault weapon
1.21	under section 624.713, subdivision 1; and

2.1 (4) a statement by the proposed transferee that the proposed transferee is not prohibited
2.2 by section 624.713 from possessing a pistol or semiautomatic military-style assault weapon.

2.3 The statements shall be signed and dated by the person applying for a permit. At the
2.4 time of application, the local police authority shall provide the applicant with a dated receipt
2.5 for the application. The statement under clause (3) must comply with any applicable
2.6 requirements of Code of Federal Regulations, title 42, sections 2.31 to 2.35, with respect
2.7 to consent to disclosure of alcohol or drug abuse patient records.

Subd. 2. Investigation. The chief of police or sheriff shall check criminal histories,
records and warrant information relating to the applicant through the Minnesota Crime
Information System, the national criminal record repository, and the National Instant Criminal
Background Check System. The chief of police or sheriff shall also make a reasonable effort
to check other available state and local record-keeping systems. The chief of police or sheriff
shall obtain commitment information from the commissioner of human services as provided
in section 245.041.

Subd. 3. Forms. Chiefs of police and sheriffs shall make transferee permit application
forms available throughout the community. There shall be no charge for forms, reports,
investigations, notifications, waivers or any other act performed or materials provided by
a government employee or agency in connection with application for or issuance of a
transferee permit.

Subd. 4. Grounds for disqualification. A determination by (a) The chief of police or
sheriff that shall refuse to grant a transferee permit if the applicant is: (1) prohibited by
section 624.713 state or federal law from possessing a pistol or semiautomatic military-style
assault weapon shall be the only basis for refusal to grant a transferee permit; (2) determined
to be a danger to self or the public when in possession of firearms under paragraph (b); or
(3) listed in the criminal gang investigative data system under section 299C.091.

(b) A chief of police or sheriff shall refuse to grant a permit to a person if there exists a 2.26 substantial likelihood that the applicant is a danger to self or the public when in possession 2.27 of a firearm. To deny the application pursuant to paragraph (a), clause (2), the chief of police 2.28 or sheriff must provide the applicant with written notification and the specific factual basis 2.29 justifying the denial, including the source of the factual basis. The chief of police or sheriff 2.30 must inform the applicant of the applicant's right to submit, within 20 business days, any 2.31 additional documentation relating to the propriety of the denial. Upon receiving any additional 2.32 documentation, the chief of police or sheriff must reconsider the denial and inform the 2.33 applicant within 15 business days of the result of the reconsideration. - reconsideration must be in the same form and substance as the original denial and must 3.1 specifically address any continued deficiencies in light of the additional documentation 3.2 3.3 submitted by the applicant. The applicant must be informed of the right to seek de novo review of the denial as provided in subdivision 8. 3.4 (c) A person is not eligible to submit a permit application under this section if the person 3.5 has had an application denied pursuant to paragraph (b) and less than six months have 3.6 elapsed since the denial was issued or the person's appeal under subdivision 8 was denied, 3.7 whichever is later. 3.8 (d) A chief of police or sheriff who denies a permit application pursuant to paragraph 3.9 (b) must provide a copy of the notice of disqualification to the chief of police or sheriff with 3.10 joint jurisdiction over the proposed transferee's residence. 3.11 Subd. 5. Granting of permits. A transferee permit may be renewed in the 3.18 same manner and subject to the same provisions by which the original permit was obtained, 3.19 except that all renewed permits must comply with the standards adopted by the commissioner 3.20 under section 624.7151. Permits issued pursuant to this section are not transferable. A person 3.21 who transfers a permit in violation of this subdivision is guilty of a misdemeanor. 3.22 Subd. 7. Permit voided; revocation. (a) The transferee permit shall be void at the time 3.23 that the holder becomes prohibited from possessing or receiving a pistol under section 3.24 3.25 624.713, in which event the holder shall return the permit within five days to the issuing authority. If the chief law enforcement officer who issued the permit has knowledge that 3.26 the permit holder is ineligible to possess firearms, the chief law enforcement officer must 3.27 revoke the permit and give notice to the holder in writing. Failure of the holder to return 3.28
- 3.29 the permit within the five days <u>of learning that the permit is void or revoked is a gross</u>
- 3.30 misdemeanor unless the court finds that the circumstances or the physical or mental condition
- 3.31 of the permit holder prevented the holder from complying with the return requirement.

4.12	applicable chief of police or sheriff as the respondent. The district court must hold a hearing
4.13	at the earliest practicable date and in any event no later than 60 days following the filing of

4.15	of the hearing. The record of the hearing must be sealed. The matter must be heard de novo

 6.5 report shall be delivered by the transferor to the chief of police or sheriff no later than three

 6.7 The statement under clause (3) must comply with any applicable requirements of Code of
 6.8 Federal Regulations, title 42, sections 2.31 to 2.35, with respect to consent to disclosure of
 6.9 alcohol or drug abuse patient records.
- Subd. 2. Investigation. Upon receipt of a transfer report, the chief of police or sheriff
 shall check criminal histories, records and warrant information relating to the proposed
 transferee through the Minnesota Crime Information System, the national criminal record
 repository, and the National Instant Criminal Background Check System. The chief of police
 or sheriff shall also make a reasonable effort to check other available state and local
 record-keeping systems. The chief of police or sheriff shall obtain commitment information
 from the commissioner of human services as provided in section 245.041.
- 6.17 Subd. 3. Notification. The chief of police or sheriff shall notify the transferor and
 6.18 proposed transferee in writing as soon as possible if the chief or sheriff determines that the
 6.19 proposed transferee is prohibited by section 624.713 from possessing a pistol or
 6.20 semiautomatic military-style assault weapon. The notification to the transferee shall specify
 6.21 the grounds for the disqualification of the proposed transferee and shall set forth in detail
 6.22 the transferee's right of appeal under subdivision 13.

Subd. 4. Delivery. Except as otherwise provided in subdivision 7 or 8, no person shall 6.23 deliver a pistol or semiautomatic military-style assault weapon to a proposed transferee 6.24 until five business 30 days after the date the agreement to transfer is delivered to a chief of 6.25 police or sheriff in accordance with subdivision 1 unless the chief of police or sheriff waives 6.26 all or a portion of the seven-day waiting period. The chief of police or sheriff may waive 6.27 6.28 all or a portion of the five business day waiting period in writing if the chief of police or sheriff: (1) determines the proposed transferee is not disqualified prior to the waiting period 6.29 concluding; or (2) finds that the transferee requires access to a pistol or semiautomatic 6.30 military-style assault weapon because of a threat to the life of the transferee or of any member 6.31 of the household of the transferee.
