1.5 Subdivision 1. **Terms of covenant.** (a) In every lease or license of residential
1.6 premises, whether in writing or parol, the landlord or licensor and the tenant or licensee
1.7 covenant that:

1.8 (1) neither will:

1.9 (i) unlawfully allow controlled substances in those premises or in the common
1.10 area and curtilage of the premises;

1.11 (ii) allow prostitution or prostitution-related activity as defined in section 617.80,
1.12 subdivision 4, to occur on the premises or in the common area and curtilage of the premises;

1.13 (iii) allow the unlawful use or possession of a firearm in violation of section 609.66,
1.14 subdivision 1a, 609.67, or 624.713, on the premises or in the common area and curtilage
1.15 of the premises; or

1.16 (iv) allow stolen property or property obtained by robbery in those premises or in the
1.17 common area and curtilage of the premises; and

1.18 (2) the common area and curtilage of the premises will not be used by either the
1.19 landlord or licensor or the tenant or licensee or others acting under the control of either to
1.20 manufacture, sell, give away, barter, deliver, exchange, distribute, purchase, or possess a
1.21 controlled substance in violation of any criminal provision of chapter 152. The covenant
1.22 is not violated when a person other than the landlord or licensor or the tenant or licensee
1.23 possesses or allows controlled substances in the premises, common area, or curtilage,

1.25 that activity.

2.6 Subdivision 1. **Right to terminate; procedure.** ~~(a) A tenant to a residential lease~~
2.7 ~~who is a victim of domestic abuse and fears imminent domestic abuse against the tenant~~
2.8 ~~or the tenant's minor children if the tenant or the tenant's minor children remain in the~~
2.9 ~~leased premises may terminate a lease agreement without penalty or liability as provided~~
2.10 ~~in this section. The tenant must provide advance written notice to the landlord stating that~~
2.11 A tenant to a residential lease may terminate a lease agreement in the manner provided in
2.12 this section without penalty or liability, if the tenant or another authorized occupant fears
2.13 imminent violence after being subjected to:

2.14 (1) ~~the tenant fears imminent domestic abuse from a person named in an order~~
2.15 ~~for protection or no contact order~~ domestic abuse, as that term is defined under section
2.16 518B.01, subdivision 2;

2.17 (2) ~~the tenant needs to terminate the tenancy; and~~ criminal sexual assault, as that

2.21 (b) The tenant must provide signed and dated advance written notice to the landlord:

2.22 (1) stating the tenant fears imminent violence against the tenant or an authorized
2.23 occupant if the tenant or authorized occupant remains in the leased premises as indicated
2.24 in a qualifying document;

2.25 (2) stating that the tenant needs to terminate the tenancy;

2.26 (3) providing the date by which the tenant will vacate;

2.27 (4) providing written instructions for the disposition of any remaining personal
2.28 property in accordance with section 504B.271; and

2.29 (5) providing the name of the perpetrator, if it is safe to provide.

2.30 (c) The written notice must be delivered before the termination of the tenancy by
2.31 mail, fax, or in person, and be accompanied by the order for protection or no contact order
2.32 a qualifying document.

2.33 (e) ~~For purposes of this section, an order for protection means an order issued under~~
2.34 ~~chapter 518B. A no contact order means a no contact order currently in effect, issued~~

3.1 (d) The tenancy terminates, including the right of possession of the premises, as
3.2 provided in subdivision 3.

3.3 Subd. 2. **Treatment of information.** A landlord must not disclose information
3.4 provided to the landlord by a tenant documenting domestic abuse under subdivision 1.
3.5 The information must not be entered into any shared database or provided to any person or
3.6 entity but may be used when required as evidence in an eviction proceeding, action for
3.7 unpaid rent or damages arising out of the tenancy, claims under section 504B.178, with
3.8 the consent of the tenant, or as otherwise required by law.

3.9 Subd. 2a. **Forms.** A document produced by a qualified third party must be
3.10 substantially in the following form:

3.11 STATEMENT BY QUALIFIED THIRD PARTY

3.12 I, (name of qualified third party), do hereby verify as follows:

3.27 Subd. 3. **Liability for rent; termination of tenancy.** (a) A tenant who is a sole
3.28 tenant and is terminating a lease under subdivision 1 is responsible for the rent payment
3.29 for the full month in which the tenancy terminates ~~and an additional amount equal to one~~
3.30 ~~month's rent.~~ The tenant forfeits all claims for the return of the security deposit under
3.31 section 504B.178 and is relieved of any other contractual obligation for payment of rent or
3.32 any other charges for the remaining term of the lease, except as provided in this section. In
3.33 a sole tenancy, the tenancy terminates on the date specified in the notice provided to the
3.34 landlord as required under subdivision 1.

3.35 (b) In a tenancy with multiple tenants, any lease governing all tenants is terminated

4.30 (1) "Court official" means a judge, referee, court administrator, prosecutor, probation
 4.31 officer, or victim's advocate, whether employed by or under contract with the court, who is
 4.32 authorized to act on behalf of the court;

4.33 (2) "Qualified third party" means a person that has had in-person contact with either
 4.34 the tenant or authorized occupant and is:

5.19 Subd. 7. **Conflicts with other laws.** If a federal statute, regulation, or handbook
 5.20 permitting termination of a residential tenancy subsidized under a federal program
 5.21 conflicts with any provision of this section, then the landlord must comply with the federal
 5.22 statute, regulation, or handbook.

5.24 Subdivision 1. **Grounds.** (a) The person entitled to the premises may recover
 5.25 possession by eviction when:

5.26 (1) any person holds over real property:

5.27 (i) after a sale of the property on an execution or judgment; or

5.28 (ii) after the expiration of the time for redemption on foreclosure of a mortgage, or
 5.29 after termination of contract to convey the property;

5.30 (2) any person holds over real property after termination of the time for which it is
 5.31 demised or leased to that person or to the persons under whom that person holds possession,
 5.32 contrary to the conditions or covenants of the lease or agreement under which that person
 5.33 holds, or after any rent becomes due according to the terms of such lease or agreement; or

5.34 (3) any tenant at will holds over after the termination of the tenancy by notice to quit.

6.1 (b) A landlord may not commence an eviction action against a tenant or lawful
6.2 occupant solely on the basis that the tenant or lawful occupant has been the victim of
6.3 any of the acts listed in section 504B.206, subdivision 1, paragraph (a). Nothing in this
6.4 paragraph should be construed to prohibit an eviction action based on a breach of the lease.
