- 2.6 (ii) veteran-owned small businesses;
- 2.7 (3) a review of goals and good faith efforts to use small targeted group businesses
- 2.8 and veteran-owned small businesses in subcontracts, including analysis of methods used
- 2.9 for, and effectiveness of, good faith efforts;
- 2.10 (4) a summary of any financial incentives used or sanctions imposed;
- 2.11 (5) agency commentary on any perceived impediments, whether statutory,
- 2.12 administrative or otherwise, that may be limiting the participation of small targeted
- 2.13 group businesses and veteran owned small businesses in the agency's contract preference
- 2.14 program; and
- 2.15 (6) any recommendations for legislative or programmatic changes."
