7.10 Subdivision 1. **Public policy.** (a) Recognizing the importance of protections
 7.11 afforded children by their ability to develop strong parental bonds, and recognizing the
 7.12 fundamental right and liberty interest that parents enjoy regarding the care, custody, and
 7.13 companionship of their children, the legislature finds and declares the following with
 7.14 respect to the intent of Minnesota laws relating to families:

7.15 (1) an intact, involved two-parent home provides the optimal environment through
 7.16 which children grow into productive and responsible adult citizens;

7.17 (2) parents play the primary role in the nurturing and development of their children.
 7.18 Our society, state, and statutes are secondary structures designed to support, not supplant,
 7.19 both parents in their role as the primary shapers of their children;

7.20 (3) mothers and fathers provide unique and invaluable contributions toward the
 7.21 development of their children. Each parent's contributions to the upbringing of their
 7.22 children are indistinguishable and equally necessary to assure children the best opportunity
 7.23 to develop into healthy citizens;

7.24 (4) children should be separated from their parents only under the most compelling
 7.25 and unusual circumstances in order to protect a child from endangerment;

7.26 (5) it is in the best interests of children to have frequent and continuing physical
 7.27 contact with both parents under joint legal and joint physical custody when the parents
 7.28 live separately, including after parental separation or dissolution of marriage. The proper
 7.29 role of the state is to interfere to the least degree in familial relationships with the specific
 7.30 purpose of preserving maximum time allocations with each parent and their children;

7.31 (6) parents may, and should be encouraged to, reach any agreement mutually
 7.32 acceptable to them regarding their parenting time allocations that reflects the individual
 7.33 circumstances of the parents and children. In the event parents cannot reach agreement on
 7.34 a parenting arrangement, it is the specific intent of Minnesota law that parents have a right
 7.35 to a rebuttable presumption of equal time with their children; and

8.1 (7) the judiciary in contested custody proceedings should demonstrate consistent
8.2 application of the rebuttable presumption in favor of joint legal and joint physical custody
8.3 in order to minimize the adversarial nature of custody proceedings.

8.4 (b) The purpose of this section is to prevent children from being alienated or
8.5 disenfranchised from their parents' lives through the unwarranted interference of either
8.6 parent.

8.7 (c) This section establishes clear legislative policy regarding the relationship of
8.8 children with each parent when the parents live separately.

8.9 (d) In accordance with the findings in paragraph (a), the legislature declares that
8.10 public policy is advanced and the best interests of children are promoted through equal and
8.11 shared parenting and the recognition of both parents' fundamental freedoms to actively
8.12 participate in the care, custody, and companionship of their children.

8.13 **Subd. 2. Presumption of joint legal and physical custody and shared parenting.**
8.14 This subdivision applies to temporary and final orders in marriage dissolution or parentage
8.15 cases. Upon request of either or both parties, the court shall use a rebuttable presumption
8.16 that joint legal custody and joint physical custody, with equal shared parenting, is in the
8.17 best interests of the child. For purposes of this subdivision, "equal" means a minimum
8.18 parenting time for each parent of 45.1 percent. The percentage of parenting time may be
8.19 determined by calculating the number of overnights that a child spends with a parent or by
8.20 using a method other than overnights if the parent has significant time periods on separate
8.21 days when the child is in the parent's physical custody but does not stay overnight. The
8.22 parenting time must be spread throughout one calendar year in a way that best meets
8.23 variable circumstances for the parties, unless both parents agree to a different division
8.24 of time or schedule.

8.25 **Subd. 3. Overcoming presumption.** If the parents are unable to reach an
8.26 agreement on joint legal and joint physical custody and equal shared parenting, the
8.27 burden of overcoming the presumption of joint legal custody, joint physical custody, and
8.28 equal shared parenting rests on the parent challenging the presumption. To overcome
8.29 the presumption, the court must find that the parent challenging the presumption has
8.30 established by clear and convincing evidence that:

8.31 (1) the other parent's actions rise to the level of endangering the child due to any of
8.32 the following:

8.33 (i) abandonment under section 260C.007, subdivision 6, clause (1), 260C.301,
8.34 subdivision 2, or 518.1705, subdivision 6, paragraph (b), clause (3);

8.35 (ii) physical or sexual abuse under section 260C.007, subdivision 6, clause (2);

8.36 (iii) neglect under section 260C.007, subdivision 6, clause (3) or (8);

9.1 (iv) allowing the child to live in injurious or dangerous conditions under section
9.2 260C.007, subdivision 6, clause (9);

9.3 (v) egregious harm under section 260C.007, subdivision 14;

9.4 (vi) emotional maltreatment under section 260C.007, subdivision 15;

9.5 (vii) great bodily harm under section 609.02, subdivision 7;

9.6 (viii) conviction of child abuse as defined in section 609.185, clause (b);

9.7 (ix) child maltreatment under section 626.556, subdivision 2, clauses (c) to (g); or

9.8 (x) domestic abuse as defined in section 518B.01, except when:

9.9 (A) a parent has petitioned for an order for protection and the petition has been
9.10 dismissed or denied by a court, or an order for protection was filed by agreement of the
9.11 parties without a finding of domestic abuse and the agreement and order incorporating the
9.12 agreement did not provide otherwise, in which case the court must find that no domestic
9.13 abuse has occurred with respect to matters that were alleged or could have been alleged; or

9.14 (B) a parent knowingly makes false allegations of domestic abuse as defined in
9.15 section 518B.01, subdivision 2. Making a false allegation of abuse is sufficient grounds to
9.16 challenge the custody and parenting time of the accuser. Allegations raised in the context
9.17 of custody proceedings that do not display evidence of a previous pattern of abuse deserve
9.18 heightened scrutiny as to their veracity; or

9.19 (2) the other parent is incapable of self-management or management of personal
9.20 affairs and would jeopardize the safety of the children due to current habitual and
9.21 excessive use of alcohol, drugs, or other mind-altering substances and the related actions
9.22 due to the substance abuse demonstrate endangerment to the well-being of the child.

9.23 Subd. 4. **Consideration of geographic limitations.** This subdivision applies when
9.24 the presumption has not been overcome, but due to the parents' different geographic
9.25 locations, a 45.1 percent minimum parenting time for each parent would prevent the
9.26 parents from keeping the child in one school during a school year. During the pendency of
9.27 the custody proceeding, the child shall remain in the same school district which the child
9.28 currently attends or most recently attended, unless the parents agree otherwise, or except
9.29 in cases under section 518B.01 where the parent or child involved in the proceeding is
9.30 endangered. If the parents do not agree otherwise, the court shall determine which parent
9.31 has the majority of parenting time using the best interests of the child factors under section
9.32 518.17, subdivision 1, provided that a minimum of 25 percent parenting time must be
9.33 granted to the other parent, making every attempt to exceed this amount and maximize
9.34 the parental involvement of each parent.

9.35 Subd. 5. **Findings and order.** (a) If the court finds the presumption has been
9.36 overcome, the court shall make detailed written findings that enumerate and explain
