1.3 certain licensure and grant provisions; prohibiting postsecondary institutions from

1.4 considering certain criminal records during the application process; providing that

1.5 postsecondary education participation satisfies employment requirements for

1.16 Section 1. Laws 2022, chapter 42, section 2, is amended to read:

1.17 Sec. 2. **APPROPRIATION; ALS RESEARCH.**

1.18 (a) ~~\$20,000,000~~ \$396,000 in fiscal year 2023 is appropriated from the general fund to

1.19 the commissioner of the Office of Higher Education to award competitive grants to applicants

1.20 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with

1.21 the Minnesota Department of Health to administer the grant program, including identifying

1.22 clinical and translational research and innovations, developing outcomes and objectives

1.23 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,

1.24 and application review and grant recipient selection. Not more than \$400,000 may be used

1.25 by the commissioner to administer the grant program. This is a onetime appropriation.

2.1 Notwithstanding Minnesota Statutes, section 16A.28, unencumbered balances under this  
 2.2 section do not cancel until June 30, 2026.

2.3 (b) \$19,604,000 in fiscal year 2024 is appropriated from the general fund to the  
 2.4 commissioner of the Office of Higher Education to award competitive grants to applicants  
 2.5 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with  
 2.6 the Minnesota Department of Health to administer the grant program, including identifying  
 2.7 clinical and translational research and innovations, developing outcomes and objectives  
 2.8 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,  
 2.9 and application review and grant recipient selection. Up to \$15,000,000 may be used by the  
 2.10 commissioner for grants to the Amyotrophic Lateral Sclerosis Association, Never Surrender,  
 2.11 or other similar organizations to award and administer competitive grants to applicants for  
 2.12 research into ALS under this section. This is a onetime appropriation. Notwithstanding

6.1 Sec. 5. **APPROPRIATION; KIDS ON CAMPUS INITIATIVE.**

6.2 \$500,000 in fiscal year 2025 is appropriated from the general fund to the Board of  
 6.3 Trustees of the Minnesota State Colleges and Universities to participate in the Kids on  
 6.4 Campus initiative with the National Head Start Association and the Association of  
 6.5 Community College Trustees. This appropriation may be used for a temporary statewide  
 6.6 project coordinator, stipends to campuses and Head Start centers where letters of intent to  
 6.7 officially form a partnership have been signed, engaging with local Head Start programs,  
 6.8 and other costs associated with creating campus Head Start partnerships. Stipends shall be  
 6.9 used to support the formation of parenting student advisory panels to gather perspective  
 6.10 and feedback on proposed partnerships. The duties of the temporary statewide project  
 6.11 coordinator include assessing the feasibility of partnerships between Minnesota State Colleges  
 6.12 and Universities campuses and Head Start programs across the state, consulting with the  
 6.13 Minnesota Head Start Association and existing Head Start partnership programs to develop  
 6.14 best practices, working with campus-based navigators for parenting students to provide  
 6.15 resources for financial aid and basic needs support to Head Start programs, and developing  
 6.16 strategies to grow the early childhood care and education workforce through partnerships  
 6.17 between Head Start programs and early childhood degree and certificate programs. This is  
 6.18 a onetime appropriation and is available until June 30, 2026.

6.20 **HIGHER EDUCATION POLICY**

6.21 Section 1. **[135A.062] CONSIDERATION OF CRIMINAL RECORDS LIMITED.**

6.22 Subdivision 1. **Applicability.** This section applies to postsecondary institutions under  
 6.23 section 136A.155, except that the Board of Regents of the University of Minnesota is  
 6.24 requested to comply with this section.

6.25 Subd. 2. **Definition.** As used in this section, "a violent felony or sexual assault" includes  
 6.26 a felony-level violation or attempted violation of section 609.185; 609.19; 609.195; 609.20;  
 6.27 609.221; 609.2242, subdivision 4; 609.2247; 609.245, subdivision 1; 609.247, subdivision  
 6.28 2; 609.282; 609.322; 609.342; 609.343; 609.344; 609.345; 609.3451; 609.3458; 609.561,  
 6.29 subdivision 1 or 2; 609.582, subdivision 1; 609.66, subdivision 1e; or 609.749.

6.30 Subd. 3. **Consideration of criminal records limited.** A postsecondary institution may  
 6.31 not inquire into, consider, or require disclosure of the criminal record or criminal history  
 6.32 of an applicant for admission. After a postsecondary institution has made an offer of  
 6.33 admission, the postsecondary institution may inquire into, consider, or require disclosure

7.1 of a conviction that occurred within the previous five years for a violent felony or sexual  
 7.2 assault. The postsecondary institution must provide the applicant with an opportunity to  
 7.3 submit an explanatory statement, letters of recommendation, evidence of rehabilitation, and  
 7.4 any other supporting documents. The institution must provide clear and detailed instructions  
 7.5 and guidance to applicants related to what criminal history requires disclosure. The institution  
 7.6 must not require the applicant to provide official records of criminal history. A postsecondary  
 7.7 institution that rescinds an offer of admission must:

7.8 (1) provide an explanation of the basis for the decision to rescind the offer of admission;  
 7.9 and

7.10 (2) provide the applicant with an opportunity to appeal the decision to rescind.

7.11 Subd. 4. **Other information.** This section shall not prohibit or limit a postsecondary  
 7.12 institution from inquiring about student conduct records at the applicant's prior postsecondary  
 7.13 institution after making an offer of admission. This section shall not prohibit or limit a  
 7.14 postsecondary institution from inquiring about a student's ability to meet licensure  
 7.15 requirements in a professional program after making an offer of admission.

7.16 Subd. 5. **Limitation on admissibility.** (a) A postsecondary institution that complies  
 7.17 with this section is immune from liability in a civil action arising out of the institution's  
 7.18 decision to admit a student with a criminal history or the institution's failure to conduct a  
 7.19 criminal background check.

7.20 (b) Nothing in this section creates or establishes a legal duty upon a postsecondary  
 7.21 institution to inquire into or require disclosure of the criminal history or criminal convictions  
 7.22 of a student or an applicant for admission.

7.23 Sec. 2. Minnesota Statutes 2022, section 136A.29, subdivision 9, is amended to read:

7.24 Subd. 9. **Revenue bonds; limit.** The authority is authorized and empowered to issue  
 7.25 revenue bonds whose aggregate principal amount at any time shall not exceed ~~\$1,300,000,000~~  
 7.26 \$2,000,000,000 and to issue notes, bond anticipation notes, and revenue refunding bonds  
 7.27 of the authority under the provisions of sections 136A.25 to 136A.42, to provide funds for  
 7.28 acquiring, constructing, reconstructing, enlarging, remodeling, renovating, improving,  
 7.29 furnishing, or equipping one or more projects or parts thereof.

 9.9 corrections shall relay this information to the commissioner of higher education. The  
 9.10 commissioner of corrections, in consultation with the commissioner of higher education,  
 9.11 shall develop a plan by December 1, 2024, to assist incarcerated persons in enrolling in a  
 9.12 federal income-driven repayment plan in which there are no monthly payments or accrual  
 9.13 of interest for borrowers with earnings below the federal poverty guidelines.

10.6 (1) for a private career school that offers one program, the license renewal fee is \$1,150;

10.7 (2) for a private career school that offers more than one program, the license renewal  
10.8 fee is \$1,150, plus \$200 for each additional program with a maximum renewal licensing  
10.9 fee of \$2,000;

10.10 (3) for a private career school licensed exclusively due to the use of the term "college,"  
10.11 "university," "academy," or "institute" in its name, the license renewal fee is \$750; and

10.12 (4) for a private career school licensed by another state agency and also licensed with

11.2 136A.62, subdivision 3, clause (2), item (ii); or

11.3 (2) charges incarcerated students a higher per-credit rate than the rate for nonincarcerated  
11.4 students.

11.5 **Sec. 8. [244.60] SUPERVISED RELEASE EMPLOYMENT REQUIREMENT;**  
11.6 **POSTSECONDARY EDUCATION.**

11.7 If the commissioner of corrections imposes a requirement on a person placed on  
11.8 supervised release that the person work or be employed, the commissioner shall provide  
11.9 that enrollment and participation in postsecondary education satisfies this requirement.

11.10 **Sec. 9. REPEALER.**

11.11 Minnesota Statutes 2022, sections 241.265; and 609B.311, are repealed.

APPENDIX  
Repealed Minnesota Statutes: S5326-2

**241.265 HIGHER EDUCATION; CERTAIN PAYMENTS PROHIBITED.**

The commissioner may not pay for a college education program beyond the associate of arts degree level for an inmate convicted of first- or second-degree murder. The commissioner of corrections may only pay for an associate of arts college education program for an inmate convicted of first or second degree murder if the inmate's participation in the program does not increase the cost of the program to the institution.

**609B.311 MURDER CONVICTION; HIGHER EDUCATION PAYMENTS FOR PRISON INMATES LIMITED.**

Section 241.265 prohibits the commissioner of corrections from paying for certain higher education programs for an inmate convicted of first- or second-degree murder.
