(a) The commissioner of veterans affairs shall determine a suitable site and plan for 2.24 2.25 three four new state veterans cemeteries, one to be located in northeastern Minnesota, one to be located in northwestern Minnesota, one to be located in southeastern Minnesota, and 2.26 one to be located in southwestern Minnesota. In determining the site for a cemetery, the 2.27 commissioner shall consider available public land options and shall seek proposals for 2.28 donated land from interested counties, local communities, civic organizations, veterans 2.29 service organizations, and individuals. 2.30

(b) For determining the veterans cemetery site in southeastern Minnesota, the 2.31 commissioner shall give priority consideration to land owned and proposed for donation 2.32 by the county of Fillmore. 2.33
