## **Bill Description**

This bill allows lease levy to fund the retirement of a lease purchase agreement. The lease purchase agreement will provide the funds for the acquisition of a transportation hub by District 112, Eastern Carver County Schools. The district must demonstrate significant cost savings to the commissioner for this lease levy authorization.

### **Assumptions**

The district has costs estimates for the project at approximately \$15,000,000. The lease levies for this project estimated by the district will be approximately \$1,000,000 in principal and interest per year for 20 years.

The costs for this project are within the district's lease levy authority of \$212 times the adjusted pupil units for the fiscal year to which the levy is attributable (M.S. 126C.40, Subd.1(e)).

There are no state aid impacts.

## **Expenditure and/or Revenue Formula**

Estimated expenditures have been supplied by staff at District 112.

## **Long-Term Fiscal Considerations**

No district currently has a lease levy authorization for the acquisition costs of a transportation hub. Other districts may also request this lease levy authorization for a transportation hub.

#### **Local Fiscal Impact**

District 112's annual levy for this project will be \$1,000,000.
