10.16 (10) one member appointed by the Minnesota Deputy Registrars Association;

10.17 (11) one member appointed by the Deputy Registrar Business Owners Association;

10.18 (12) one member appointed by the Minnesota Automobile Dealers Association;

10.19 (13) one member appointed by AAA Minnesota; and

10.20 (14) one member appointed by the Minnesota Transportation Alliance.

10.21 (b) The commissioner may solicit participation in the working group by additional
10.22 individuals if the commissioner determines that particular expertise or perspective would
10.23 be beneficial to the working group in the performance of its duties.

10.24 Subd. 4. **Appointment; vacancy.** Members of the working group serve at the pleasure
10.25 of the appointing authority or until the working group expires. Vacancies must be filled by
10.26 the appointing authority.

10.27 Subd. 5. **Duties.** (a) At a minimum, the working group must:

10.28 (1) identify and evaluate potential methods for enforcement of motor vehicle registration
10.29 and registration tax payment requirements that would replace enforcement through the use
10.30 of criminal penalties, including but not limited to:

11.1 (i) alignment with individual income taxes;
11.2 (ii) revenue recapture; and
11.3 (iii) retention of license plates with a vehicle following a change of vehicle ownership;
11.4 and

11.5 (2) develop recommendations, a legislative proposal, or both, related to motor vehicle
11.6 registration and registration tax compliance through methods other than the use of criminal
11.7 penalties.

11.8 (b) In evaluating methods under paragraph (a), clause (2), the working group must use
11.9 criteria that include effectiveness, administrative efficiency, equity, burdens on motor vehicle
11.10 owners, and substantial elimination of vehicle registration enforcement through traffic stops
11.11 performed by peace officers.

11.12 Subd. 6. **Administration.** (a) The commissioner must provide administrative support
11.13 to the working group. Upon request of the working group, the commissioners of
11.14 transportation and revenue must provide relevant technical support.

11.15 (b) Members of the working group are not eligible for compensation.

11.16 (c) The working group is subject to the Minnesota Open Meeting Law under Minnesota

11.27 **DRUG USE.**

11.28 Subdivision 1. **Establishment.** The Task Force on Holistic and Effective Responses to
11.29 Illicit Drug Use is established to review the reports on approaches to address illicit drug use
11.30 in Minnesota prepared and submitted pursuant to Laws 2023, chapter 52, article 2, section
11.31 3, subdivision 8, paragraph (v); develop a phased timeline for implementation of policy
11.32 changes; and make policy and funding recommendations to the legislature.

12.1 Subd. 2. **Membership.** (a) The task force consists of the following members:

12.2 (1) the state public defender or a designee;

12.3 (2) two county attorneys, one from a county in the metropolitan area as defined in
12.4 Minnesota Statutes, section 473.121, subdivision 2, and one from a county outside the
12.5 metropolitan area, appointed by the Minnesota County Attorneys Association;

12.6 (3) one peace officer, as defined in Minnesota Statutes, section 626.84, subdivision 1,
12.7 paragraph (c), appointed by the Minnesota Sheriffs' Association;

12.8 (4) one peace officer, as defined in Minnesota Statutes, section 626.84, subdivision 1,
12.9 paragraph (c), appointed by the Minnesota Police and Peace Officers Association;

12.10 (5) two medical professionals, of whom one has expertise in substance use disorder
12.11 treatment and one has experience working with harm reduction providers, appointed by the
12.12 Minnesota Medical Association;

12.13 (6) one member appointed by the Minnesota Association of Criminal Defense Lawyers;

12.14 (7) one member representing a Tribal government, appointed by the Indian Affairs
12.15 Council;

12.16 (8) one member with knowledge of expungement law, representing criminal legal reform
12.17 organizations;

12.18 (9) one academic researcher specializing in drug use or drug policy;

12.19 (10) one member with lived experience with drug use;

12.20 (11) one member who resides in a community that has been disproportionately impacted
12.21 by drug sentencing laws;

12.22 (12) one member representing an organization with knowledge of youth intervention
12.23 services and the juvenile justice system; and

12.24 (13) one member, appointed by the Minnesota Association of County Social Service
12.25 Administrators, with experience administering supportive social services, including mental
12.26 health, substance use disorder, housing, and other related services.

12.27 (b) The members identified in paragraph (a), clauses (8) to (12), must be appointed by
12.28 the governor.

12.29 (c) Appointments must be made no later than August 31, 2024.

12.30 (d) Members of the task force serve without compensation.

13.1 (e) Members of the task force serve at the pleasure of the appointing authority or until
13.2 the task force expires. Vacancies shall be filled by the appointing authority consistent with
13.3 the qualifications of the vacating member required by this subdivision.

13.4 Subd. 3. **Duties.** (a) The task force must:

13.5 (1) review and analyze the research and recommendations released in reports prepared
13.6 by Rise Research pursuant to Laws 2023, chapter 52, article 2, section 3, subdivision 8,
13.7 paragraph (v);

13.8 (2) collect, review, and analyze other relevant information and data;

13.9 (3) gather and consider input and feedback from the public, including but not limited to
13.10 feedback from individuals with lived experience involving the use of illicit drugs and family
13.11 members of persons with that lived experience; and

13.12 (4) make recommendations, including specific plans and timeline goals, to implement
13.13 and fund policies addressing illicit drug use, with the goal of reducing and, where possible,
13.14 preventing harm to users of illicit drugs and promoting the health and safety of individuals
13.15 and communities.

13.16 (b) The task force may examine other issues relevant to the duties specified in this
13.17 subdivision.

13.18 Subd. 4. **Officers; meetings.** (a) The director of the Office of Addiction and Recovery
13.19 shall convene the first meeting of the task force by September 30, 2024.

13.20 (b) At the first meeting, the members of the task force shall elect a chair and vice-chair,
13.21 and may elect other officers as the members deem necessary.

13.22 (c) The task force shall meet monthly or as determined by the chair. The task force shall
13.23 meet sufficiently enough to accomplish the tasks identified in this section. Meetings of the
13.24 task force are subject to Minnesota Statutes, chapter 13D.

13.25 Subd. 5. **Staff; meeting space.** The Office of Addiction and Recovery shall provide
13.26 support staff, office and meeting space, and administrative services for the task force.

13.27 Subd. 6. **Report.** The task force must submit a report to the chairs and ranking members
13.28 of the house of representatives and senate committees with jurisdiction over public safety,
13.29 health, and human services on the work, findings, and recommendations of the task force.
13.30 The recommendations of the task force must include proposed legislation and implementation
13.31 plans. The task force must submit the report by February 15, 2025. The task force may
13.32 submit additional information to the legislature.

14.1 Subd. 7. **Expiration.** The task force expires on June 30, 2025.

14.2 Sec. 7. **TASK FORCE ON DOMESTIC VIOLENCE AND FIREARM SURRENDER.**

14.3 Subdivision 1. **Establishment.** The Task Force on Domestic Violence and Firearm
14.4 Surrender is established to review existing laws that require the surrender of firearms by
14.5 individuals subject to an order for protection, subject to an extreme risk protection order,
14.6 or convicted of domestic assault, harassment, or stalking; identify best practices to ensure
14.7 the surrender of firearms that prioritize the safety of peace officers, victims, and others;
14.8 identify policies and procedures that reduce the danger to peace officers and other emergency
14.9 responders called to an incident involving domestic violence; and make policy and funding
14.10 recommendations to the legislature.

14.11 Subd. 2. **Membership.** (a) The task force consists of the following members:

14.12 (1) the commissioner of public safety, or a designee;

14.13 (2) the director of the Missing and Murdered Indigenous Relatives Office, or a designee;

14.14 (3) the chief justice of the supreme court, or a designee;

14.15 (4) the state public defender, or a designee;

14.16 (5) a county attorney appointed by the Minnesota County Attorneys Association;

14.17 (6) an individual appointed by the Indian Affairs Council;

14.18 (7) a peace officer as defined in Minnesota Statutes, section 626.84, subdivision 1,

14.19 paragraph (c), appointed by the Minnesota Chiefs of Police Association;

14.20 (8) a peace officer as defined in Minnesota Statutes, section 626.84, subdivision 1,

14.21 paragraph (c), appointed by the Minnesota Sheriffs' Association;

14.22 (9) an individual appointed by Violence Free Minnesota;

14.23 (10) an individual appointed by Minnesota Coalition Against Sexual Assault; and

14.24 (11) an individual appointed by the Gun Violence Prevention Law Clinic at the University

14.25 of Minnesota Law School.

14.26 (b) Appointments must be made no later than September 1, 2024.

14.27 (c) Members shall serve without compensation.

14.28 (d) Members of the task force serve at the pleasure of the appointing authority or until
