Bill Description

This statue covers employees in health care that have exposure to surgical smoke.

Subdivision 1. Definitions.

The subdivision defines the terms "Surgical smoke", "Smoke evacuation system", and "Health care employer".

Subdivision 2. Surgical smoke evacuation system policies.

Employers shall require the use of a smoke evacuation system during any surgical procedure that generates surgical smoke.

Subdivision 3. Enforcement

Enforced by the commissioner under sections 182.66 and 182.661. A violation of this section is subject to the penalties provided under section 182.666.

Assumptions

MNOSHA does not anticipate incurring additional costs related to this bill. Any additional time spent at an on-site heath care inspection would be immaterial and considered other duties as assigned through the existing complaint process and checking for compliance when conducting these health care inspections.

MNOSHA does not anticipate any additional costs associated with the contestation process. MNOSHA has reached out to several different health care facilities within the cities as well as northern and central Minnesota. They have all responded that each one currently has a smoke evacuation system, with many employers already using this technology, MNOSHA anticipates a minimal number of citations with penalties being issued and no additional penalties collected in a given year.

No additional equipment is necessary to check for smoke evacuation systems.

DLI assumes MNOSHA's Workplace Safety Consultation (WSC) unit would receive additional requests for assistance in complying with the statute. WSC will respond to any additional requests with existing staff and include the evaluation of surgical smoke compliance in originally planned visits. No additional equipment would be necessary to evaluate smoke evacuation systems.
